Traffic Regulations for Staveley 2022 and, South Lakes Speed Limits Review 2022 (Variation order No. 10) Statutory Consultations and Invitation to Comment or to Object

In October and November 2019, we wrote to you inviting you to comment in support or otherwise on the proposed traffic regulations and speed limit changes for Staveley. All responses to those initial consultations have been used to inform these proposals for formal consultation. These two statutory consultations give you the opportunity to make your comments for consideration in the final decision for either Order. Each scheme will be considered separately, therefore please provide comments to these schemes separately. The consultation and objection period is 21 days and the deadline for replies is Thursday 22nd September 2022.

During this consultation we are able to amend the proposals to be less onerous, but not more. Therefore, at the present time we are progressing with the restrictions and locations included in the 20mph Speed Limit Zone named in the draft Order and lengths of parking restrictions in the draft Order, all shown on the attached Plans. All requests relating to other restrictions or additions to the proposed the 20mph scheme cannot be considered for implementation at this time, nonetheless they can be listed for consideration in a future scheme by sending to our website, (via the report a fault tool/enquiry tool) or by calling 0300 303 2992.

Please find enclosed the following documents for each scheme:

- Statement of reasons for the proposals
- Statutory notices
- Plans of the proposals including the named properties which are included in the proposed new parking Zone A for Staveley.

When will the proposal be finalised and implemented on the ground?

Following advertising and consultation on the proposals, a report will be prepared to go before the County Council Local Committee for South Lakeland in Autumn 2022. The Committee will make the final decision as to what will be implemented. We will endeavour to inform you of the committee decision in due course. If the Committee agree to implement the proposals, the making of the traffic Order and the placing of signs and markings should take place within a 4 to 6 month period after the decision.

Statement of Reasons

Following a request from the Parish Council and the local Cumbria County Council Member Stan Collins, it is proposed to introduce a 20 mph zone on roads presently subject to a 30mph by reason of street lighting (restricted road status), with an aim to slow vehicular traffic where there are likely to be pedestrians in the road.

Cumbria County Council proposes to introduce the above Order for the following reasons set out in Sections 1(1) (a) and (c) of the Road Traffic Regulation Act 1984, namely:

- (a) for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- (c) for facilitating the passage on the road or any other road of any class of traffic (including pedestrians).



Statement of Reasons

Staveley

Proposals on Plan Labelled A-H - On Street Residential Permit Parking Proposals and, Proposal M - Shared use Loading and Waiting Limited Parking Place

Cumbria County Council considers that it is expedient to propose to make the above Order for the following reason in Section 1(1) Road Traffic Regulation Act 1984:(f) for preserving or improving the amenities of the area through which the road runs

Concerns have been raised by local residents and the local County Councillor Stan Collins regarding the lack of provision of residential and loading parking in nearby on-street unrestricted parking bays in the village centre, namely Main Street.

Therefore, it is proposed to introduce the following:-

- (i) Parking Places, 8.00 am 6.00 pm, on any day, with a waiting limit of 1 hour (return prohibited within 1 hour), for locations A-F residents of Zone A will be exempt from the waiting restrictions; and
- (ii) Parking Places 8.00 am 6.00 pm, with waiting limited to 30 minutes (return prohibited within 30 minutes) for locations G H residents of Zone A will be exempt from the waiting restrictions.
- (iii) M for Goods Vehicle Loading only Parking Places 8am-11am, on any day + Parking Places 11am -6pm, on any day, Waiting Limited to 1 hour, to help with consumer turnover.

It is proposed the residential properties eligible for Zone A Staveley permits are: -

Main Street (Odd Nos) 29-35, 47-49, 49A, 51-61, 65-69, 73-87.

Main Street (Even Nos) 14-20, 20A, 24-44, 38A, 38B, The Chapel 46-52, 40A, River View, The Barn, Beck View Gowan Bank, Gowan Bank Cottage, 2 Gowan Bank.

Proposals on Plan Labelled I-L No Waiting At Any Time and Brow Lane School Entrance Markings

Cumbria County Council considers that it is expedient to propose to make the above Order for the following reasons at the locations listed below: -

- (a) for avoiding danger to persons or other traffic using the roads or any other roads or for preventing the likelihood of any such danger arising, or
- (c) for facilitating the passage on the roads or any other road of any class of traffic (including pedestrians)

Concerns have been raised regarding parking causing obstruction and visibility issues at the junctions of Silver Street with Main Street and School Lane, at Scroggs Close, and outside Nos 75 - 77 Main Street. These locations are currently un-restricted. "No Waiting at Any Time" (double yellow lines) restrictions are proposed to assist visibility, vehicular turning movements and safety of pedestrians crossing at junctions.

At the primary school on Brow Lane we are amending the restrictions to coincide with school opening hours as signed to be No stopping on School "Keep Clear" markings, 8.15 am - 9.15 am and 3.00 pm - 4.00 pm, School Days Only.
