THE COUNTY OF CUMBRIA (VARIOUS ROADS, BARROW-IN-FURNESS) (CONSOLIDATION AND MINOR AMENDMENT OF TRAFFIC REGULATIONS) (ORDER 2001) VARIATION ORDER (NO.45) 20><

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53, 64 and 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- This Order shall come into operation on >< 20>< and may be cited as The County of Cumbria (Various Roads, Barrow-in-Furness) (Consolidation and Minor Amendment of Traffic Regulations) (Order 2001) Variation Order (No. 45) Order 20><
- 2. For the purposes of this Order the expression "the 2001 Order" shall mean The County of Cumbria (Various Roads, Barrow-in-Furness) (Consolidation and Minor Amendment of Traffic Regulations) Order 2001
- The 2001 Order shall have effect as though: -
 - (a) The lengths of road specified in Schedule VII "Prohibition of Waiting (At All Times), to this Order, was added as item numbers 1804 to 1816 inclusive of Schedule VII thereto.
 - (b) The lengths of road specified in Schedule XXXIX "Prohibition of Driving (At Any Time) (Motor Vehicles) Except for Access", to this Order, was added as item number 3 of Schedule XXXIX thereto.
 - (c) The lengths of road specified in Schedule XLVII "Prohibition of Waiting, Mon-Fri, 8 am 9 am and 2 pm 4 pm" to this Order, were added as item numbers 5 and 6 thereto.
 - (c) Part X was replaced with the following: -

PART X

PROVISION OF LOADING ONLY PARKING PLACES -

- 41. (1) Each of the lengths of road specified in **Schedule XXII** to this Order are designated as a loading only parking place between the hours of 8.00 am and 6.00 pm, Monday to Saturday inclusive.
 - (2) Each of the lengths of road specified in **Schedule XXIIA** to this Order are designated as a loading only parking place between the hours of 6.00 am and 11.00 am, Monday to Sunday inclusive

(3) Save as provided in Article 42 to this Order, no person shall, except upon the direction of a police constable or civil enforcement officer, cause or permit any vehicle to wait in those lengths of road specified in Schedules XXII and XXIIA unless goods are being loaded or unloaded from the said vehicle.

Exemptions

- 42. Nothing in Article 41 shall render it unlawful to cause or permit any vehicle to wait in the lengths of road referred to therein for so long as may be necessary to enable:-
 - (i) a person to board or alight from the vehicle;
 - (ii) the vehicle, if it cannot conveniently use another road for such purposes to be used in connection with the following operations:-
 - (a) Building and demolition work;
 - (b) The removal of any obstruction to traffic from the highway.
 - (c) The maintenance, improvement or reconstruction of any of those lengths of road.
 - (d) The laying, erection, alteration or repair of any sewer or main pipe or apparatus for the supply of gas water or electricity or of any telecommunications apparatus in or on any land adjacent to any of those lengths of road;
 - (iii) The user of the vehicle if he is employed in the services of a Local Authority or a water undertaker and is acting in pursuance of that authority's statutory powers or duties to carry out those powers or duties;
 - (iv) the vehicle to be used in connection with the delivery or collection of postal packets as defined by Section 125 of the Postal Services Act 2000:
 - any vehicle to wait at or near to any premises situated on or adjacent to any of those lengths of road for so long as is reasonably necessary where that vehicle is being used in connection with a wedding or funeral;
 - (vi) the vehicle to be used for Ambulance, Fire Brigade or Police purposes;
 - (vii) goods to be loaded or unloaded from the vehicle.
 - (d) Schedule XXIIA "Loading/Unloading Only Parking Place, Monday to Sunday inclusive 6 am 11 am" to this Order was added as Schedule XXIIA thereto

- (e) The following was added as Article 7(13): -
 - 7(13) Save as provided in Articles 23(a) to 23(i) inclusive, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait, between 8 am and 6 pm on any day, in the lengths of road or sides of road specified in Schedule LIIB to this Order: -
 - (a) For a longer period than 20 minutes; or
 - (b) If a period of less than 40 minutes has elapsed since the termination during the said 20 minutes of the last period of waiting (if any) by that vehicle on the same length of road.
- (e) Schedule LIIB "Limited Waiting Parking Place, Monday to Sunday inclusive, 8 am 6 am, 20 minutes, no return within 40 minutes" to this Order, was added as Schedule L thereto.
- (f) The following was added as Article 7(14): -
 - 7(14) Save as provided in Articles 23(a) to 23(i) inclusive, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait, between 11 am and 6 pm, on any day, in the lengths of road or sides of road specified in Schedule LIIC to this Order: -
 - (a) For a longer period than 20 minutes; or
 - (b) If a period of less than 40 minutes has elapsed since the termination during the said 20 minutes of the last period of waiting (if any) by that vehicle on the same length of road.
- (g) Schedule LIIC "Limited Waiting Parking Place, Monday to Sunday inclusive", 11 am 6pm, 20 minutes, no return within 40 minutes" to this Order, was added as Schedule LIIC thereto.
- (d) Existing Item number 70 of Schedule I "Limited Waiting Parking Place (At All Times) 10 mins no return within one hour (permit holders exempt)" which relates to Preston Street, Barrow-in-Furness, was deleted in its entirety.
- (e) Existing Item numbers 32 and 81 of Schedule III "Limited Waiting Parking Place Mon-Sat 8am 6pm, 1 hour, no return within 2 hours" which relate to Fell Street and Crellin Street, Barrow-in-Furness, respectively, were deleted in their entirety.
- (f) Existing Item numbers 784, 804, 812 and 1772 of Schedule VII "Prohibition of No Waiting At Any Time" which relate to Preston Street, Ramsden Street and Ireleth Road Barrow-in-Furness, respectively, were deleted in their entirety.

(g)	Existing Item number 6 of Schedule XXI "Loading Only Parking Place (At
	All Times)" which relates to Fell Street, Barrow-in-Furness, was deleted
	in its entirety.

- (j) Existing Item number 6 of Schedule XXII "Loading Only Parking Place Mon-Sat 8 am 6 pm" which relates to Crellin Street, Barrow-in-Furness, was deleted in its entirety.
- (h) Existing Item number 3 of Schedule XXXIX "Prohibition of Driving (At Any Time) (Motor Vehicles) Except for Access" which relates to Preston Street, Barrow-in-Furness, was deleted in its entirety.
- (i) Existing Item numbers 1 and 2 of Schedule XLVII "Prohibition of Waiting, Mon-Fri 8 am 9 am and 2 pm 4 pm" which relates to Peartree Bank and Redoak Avenue, Barrow-in-Furness, respectively, were deleted in their entirety.
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

SCHEDULE VII

Prohibition of Waiting (At All Times)

- (1804) Preston Street ,Barrow-in-Furness, the north side, from its junction with Dalton Street for a distance of 10m in a south-westerly direction.
- (1805) Hollow Lane, Barrow-in-Furness, the west side, from the centre of its junction with Yew Tree Garden for distance of 12m in a north-westh direction.
- (1806) Rakesmoor Lane, Barrow-in-Furness, the west side, from a point 12m south of its junction with Bank Lane to a ponit 12m in an north-westerly direction.
- (1807) Rakesmoor Lane, , Barrow-in-Furness, the east side, from a point 10m west of its junction with Keswick Ave to a point 10m east of that junction.
- (1808) Keswick Avenue, Barrow-in-Furness, both sides, from its junction with Rakesmoor Lane for distance of 12m in an easterly direction.
- (1809) Ireleth Road, Askam-in-Furness, the east side, from a point at the rear of No.2 Duddon View for a distance of 2.5m in an easterly direction.
- (1810) Skelwith Drive, Barrow-in-Furness, both sides, from its junction with Whinlatter Drive for distance of 14m in a southerly direction.
- (1811) Whinlatter Drive, Barrow-in-Furness, the east side, from a point 12m south-east of its junction with Keswick Ave to a point 12m north-east of that junction
- (1812) Dalton Lane, Barrow-in-Furness, the west side, from its junction with Cliff Lane for a distance of 7m in a southerly direction.
- (1813) Ramsden Street, Barrow-in-Furness, the north side, from its junction with Back Marsh Street for a distance of 36m in a westerly direction.
- (1814) Ramsden Street, Barrow-in-Furness, the south side, from its junction with Back Marsh Street for a distance 36m in a westerly direction.
- (1815) Redoak Avenue, Barrow-in-Furness, the east side, from a point 17m south-east of its junction with Peartree Bank to a point 15m north-east of that junction.
- (1816) Peartree Bank, Barrow-in-Furness, both sides, from its junction with Redoak Avenue for a distance of 10m in southerly direction

SCHEDULE XXIIA

Loading/ Unloading Only Mon-Sun 6am -11am

- (1) Fell Street, Barrow-in-Furness, the west side, from its junction with Crellin Street to a point 2m south of its junction with Cavendish Street.
- (2) Crellin Street, Barrow-in-Furness, the north-west side, from a point 10m west of its junction with Allison Street to a point 14m east of its junction with Fell Street.

SCHEDULE XXXIX

Prohibition Of Driving (at Any Time) (Motor Vehicles) Except for Access

(3) Preston Street, Barrow-in-Furness, from its junction with Dalton Street for distance of 10 metres in a south- westerly direction

SCHEDULE XLVII

Prohibition Of Waiting Mon-Fri 8am-9am and 2pm-4pm

- (5) Redoak Avenue, Barrow-in- Furness, the east side, from a point 12m south-east of its junction with Holbeck Park Avenue for a distance of 42m in a south-easterly direction.
- (6) Redoak Avenue, Barrow-in- Furness, the east side, from a point 9m southeast of its junction with Cherrytree Way for a distance of 10m in a southeasterly direction

SCHEDULE LIIIB

Limited Waiting Parking Place Mon-Sun 8am-6pm 20 mins no return within 40 mins

- (1) Preston Street, Barrow-in-Furness, the north side. from a point 30m west of its junction with Dalton Road for a distance of 24m in westerly direction.
- (2) Fell Street, Barrow-in-Furness, the east side, from a point 15m north of its junction with Crellin Street for a distance of 45m in a northerly direction.
- (3) Crellin Street, Barrow-in-Furness, the south-east side, from a point 15m south- west of its junction with Allison Street for a distance of 31 metres in a south- westerly direction.
