#### STATEMENT OF REASONS

# (As amended by South Lakeland Local Committee decision on 24 November 2022

Cumbria County Council considers that it is expedient to propose to make the above order, for the following reasons in Section 1(1) Road Traffic Regulation Act 1984, namely:-

(a) for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or

(c) for facilitating the passage on the road or any other road of any class of traffic (including pedestrians).

Concerns have been raised regarding parking causing obstruction and visibility issues at the junctions of Church Walk with Sea View and Church Fields, on Church Walk outside Number 31 and on Tarnside at the entrance to Tarnfield Place. These locations are currently un-restricted. "No Waiting at Any Time" (double yellow lines) restrictions are proposed to assist visibility, vehicular turning movements and safety of pedestrians crossing at junctions. The 'No Stopping on School Entrance Markings 8.00am-5.00pm on School Days Only' restriction outside Church Walk C.E. Primary School are also proposed to assist visibility and safety of pedestrians.

#### Local Committee Decision (Minute 56 refers): -

**RESOLVED** that, Having taken into account the objections and representations which were received during the statutory consultation and advertisement, and having also taken into consideration the matters contained in Section 122(2) of the Road Traffic Regulation Act 1984 which are more specifically referred to at paragraph 7.2 of this Report, that The County of Cumbria (Various Roads, South Lakeland) (Consolidation of Traffic Regulations) (Order 2002) (Ulverston - No.9) Variation Order 20>< ("the Order") be brought into operation as advertised.

- 2. For the purposes of this Order the expression "the 2002 Order" shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002

Tarnside	NWAAT	North	From its junction with Back Lane eastwards for a distance of 8 metres
Tarnside	NWAAT	East	From its junction with Hart Street (building line) northwards for a distance of 26m
