

# **THE COUNTY OF CUMBRIA (VARIOUS ROADS, BARROW-IN-FURNESS) (CONSOLIDATION OF TRAFFIC REGULATIONS) ORDER 2023**

The County Council of Cumbria (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

## **PART I**

### **GENERAL**

1. This Order shall come into operation on 20 March 2023 and may be cited as The County of Cumbria (Various Roads, Barrow-in-Furness) (Consolidation of Traffic Regulations) Order 2023
2. In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-
  - (1) “bus” means a motor vehicle constructed or adapted to carry more than 8 passengers which are stage carriages, scheduled express carriages, school buses and work buses;
  - (2) “delivering” and or “collecting” in relation to any goods includes checking the goods for the purpose of their delivery or collection;
  - (3) “disabled person” means a person who holds a disabled persons' badge in accordance with the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 (No. 682) (and in particular Regulation 4 thereof) or any re-enactment thereto;
  - (4) “disabled person's badge” means a badge issued in accordance with the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 (as amended) (in particular Regulation 11 and the Schedule thereto) or under regulations having effect in Scotland and Wales

under Section 21 of the Chronically Sick and Disabled Persons Act 1970 as referred to currently by the Local Authorities Traffic Orders (Exemptions for Disabled) (England) Regulations 2000 (No. 683) or any subsequent further re-enactments thereof;

- (5) “disabled person's vehicle” means a vehicle driven by a disabled person as defined in Regulation 4(2) of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 (No. 682);
- (6) “driver”, in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left in the parking place (and shall, as appropriate, bear the meaning assigned by Section 142 of the 1984 Act);
- (7) “goods” shall mean material possessions, goods, burdens and items of any description and shall include cash or other valuable securities and be of such weight or bulk that they cannot be reasonably conveyed otherwise than by means of a vehicle;
- (8) “goods vehicle” means for the purpose of this Order a motor vehicle which is constructed or adapted for the carriage of goods or burden of any description, the unladen weight of which does not exceed 1.524 tonnes;
- (9) “hackney carriage” has the same meaning as in section 38 of the Town Police Clauses Act 1847 as referred to in The Local Government (Miscellaneous Provisions) Act 1976 save further that reference to “plying for hire” shall be excluded from this definition; and “taxi” shall be construed to the extent that these terms are interchangeable;
- (10) “hackney carriage stand” means any area of the carriageway which is comprised within and indicated by road markings complying with diagram 1028.2 in Schedule 7 part 4 of the Traffic Signs Regulations and General Directions 2016;
- (11) “heavy commercial vehicle” has the same meaning as in section 138 of the 1984 Act and which has an operating weight exceeding 7.5 tonnes;
- (12) “junction” means, unless otherwise indicated in this Order, the intersection of the general alignment of the carriageway kerblines of two roads;
- (13) “local authority” means, for the purposes of this Order, a County Council or District Council;
- (14) “market permit” means a permit (as defined) issued to a market trader (as defined);
- (15) “market trader” means a person carrying out business operations during the operation of the market taking place on the lengths of road detailed in Schedule 34 to this Order;
- (16) “motor car” shall mean and include any mechanically propelled vehicle not being a motor cycle or an invalid carriage, which is constructed itself to carry passengers of which the weight unladen does not normally exceed 3050

kilograms subject always to the inclusion of the extended meaning to this term given in Section 136 of the 1984 Act (and whether or not it is being used for business purposes);

- (17) “motor cycle” and “invalid carriage” have the same meanings respectively as in Section 136 of the Act;
- (18) “motor vehicle” means any class of mechanically propelled vehicle including motor cycles motor cars goods vehicles and car derived vans, and shall bear the extended definition given thereto in Sections 136 and 137 of the 1984 Act (but shall not include any commercial vehicle as defined above or any heavy commercial vehicle as defined in Section 138 of the Act) (and whether or not it is being used for business purposes). Where reference is made to vehicle or motor vehicle in the Order these terms shall be deemed to have the same meaning and be interchangeable and to be interpreted accordingly;
- (19) “owner” in relation to a vehicle means the person by whom such vehicle is kept and used;
- (20) “Civil Enforcement Officer” shall mean the person or persons duly authorised in writing in that behalf (from time to time) by the Borough of Barrow-in-Furness;
- (21) “parking device” shall have the meaning assigned to it in the 1984 Act (Section 142; Section 35(3B); Section 51(4) and shall include parking disc;
- (22) “parking disc” means:
  - (a) in relation to Part II of this Order (Parking Places), a device which is capable of showing the quarter hour period during which a vehicle arrived at a parking place; and
  - (b) in relation to Part IV of this Order (Disabled Persons Parking Places), a device which:-
    - (i) is 123 millimetres square and coloured blue, issued on or after 1st April 2000, or orange if issued before that date;
    - (ii) has been issued by a local authority and has not ceased to be valid; and
    - (iii) is capable of showing the quarter hour period during which a period of waiting began;
- (23) “parking place” means any part of a road authorised by this Order to be used as a parking place;
- (24) “parking place” in relation to Part VI means any part of a road authorised by this Order to be used as a parking place for buses and identified by Traffic Diagram No 969 and road marking No 1028.2 complying with the 2016 Regulations or otherwise authorised by the Department for Transport;



- (25) "passenger vehicle" means a motor vehicle (other than a motor cycle, an invalid carriage, goods vehicle or heavy commercial vehicle) as defined in this Order;
- (28) "permit" means a written visitor, resident permit or market permit issued by the Council under the provisions of this Order;
- (29) "permit holder" means a person to whom a permit has been issued under the provisions of this Order;
- (30) "post office" and any reference to "post office vehicle" or "postal packets" shall be construed in the context of the Postal Services Act 2000 and the Consequential Amendments Order 2001 (No. 2001/648) and shall include therefore references to "universal service providers" such as Consignia Plc, as the context shall require;
- (31) "prescribed hours" means those hours and on those days during which there are limitations on parking, waiting, loading and unloading.
- (32) "quarter hour period" means:
- (a) in relation to Part III of this Order a period of a quarter of an hour starting at 8.00 am or at any hour or fifteen, thirty or forty-five minutes past the hour prior to the end of the prescribed hours which can be shown on the parking disc; and
  - (b) in relation to Part IV of this Order a period of quarter of an hour starting at any hour or fifteen, thirty or forty-five minutes past the hour which can be shown on the parking disc;
- (33) "registered keeper" means:-
- (a) the person whose name appears in the vehicle registration document or book of the vehicle in whose name the vehicle is registered, or
  - (b) a person who has the permanent use of the vehicle vested in the name of his employer, or in the case of a leased vehicle in the name of the leasing company;
- (34) "relevant position" means (in conformity with Regulation 12 of SI 2000 No. 682) referred to above):-
- (a) in relation to a disabled person's badge,
    - (i) in the case of a vehicle fitted with a dashboard or facia panel, the badge is exhibited thereon so that Part 1 of the badge is legible from outside the vehicle; or
    - (ii) in the case of a vehicle not fitted with a dashboard or facia panel, the badge is exhibited in a conspicuous position on the

vehicle so that Part 1 of the badge is legible from outside the vehicle

- (b) in relation to a parking device or disc (in conformity with the said 2000 Regulations (SI 2000/1519; Regulation 4):-
  - (i) in the case of a vehicle fitted with a dashboard or facia panel the disc is exhibited thereon so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle;
  - or
  - (ii) in the case of a vehicle not so fitted the disc is exhibited in a conspicuous position on the vehicle so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle
- (c) in relation to a permit or waiver
  - (i) in the case of a vehicle fitted with a front windscreen the permit is exhibited thereon on the near side of and immediately behind the windscreen and with the front facing forward so as to be legible from the outside of the vehicle; or
  - (ii) in the case of a vehicle not fitted with a front windscreen, the permit is exhibited in a conspicuous position on the vehicle;
- (35) “resident” means a person who is permanently residing (being a freeholder, leaseholder or tenant but not a lodger or licensee of any such premises) at an address which abuts or is adjacent to one of the roads comprising parking places as set out in Schedule 43 to this Order;
- (36) “resident permit” means a permit (as defined) issued to a resident (as defined);
- (37) “road” means the full width of the highway including the carriageway and footway;
- (38) “school days” means the days of the School Term;
- (39) “traffic sign” means a sign or marking of any size colour and type prescribed or authorised under, or having effect as though prescribed or authorised under, Section 64 of the 1984 Act;
- (40) “trailer” shall have the meaning assigned to it by Section 138(3) of the 1984 Act;
- (42) “The 2016 Regulations” means the Traffic Signs Regulations and General Directions 2016;
- (43) “visitor permit” means a permit (as defined) issued to a resident (as defined);

- (44) "Zone" means any of the areas which comprise the various streets (or parts thereof) set out in Schedule 43 to this Order. Residents permits will only be effective for a particular designated zone and will not be transferable.
- (44) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- (45) The Interpretation Act 1978 and any statutory modification or re-enactment thereof brought into effect after the date of this Order shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament and as if this Order were an Act of Parliament for the purposes of Section 22 of the Interpretation Act 1978.
3. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any Regulations made or having effect as if made under the Act of 1984, The Road Traffic Act 1991, or by or under any other enactment.

## **PART II**

### **DESIGNATION AND USE OF PARKING PLACES**

#### **Use of a Parking Place**

4. (1) Each of the parts of road specified in **Schedules 1 to 6J inclusive** to this Order is designated as a parking place and may be used, subject to the following provisions of this Order as a parking place during the prescribed hours for such vehicles as are passenger vehicles, motor cycles, motor cycles with side cars attached thereto, disabled persons' vehicles and goods vehicles not exceeding 5.00 metres in length and 2.28 metres in height.
- (2) Each of the parts of road specified in **Schedule 6K** to this Order is designated as a parking place and may be used, subject to the following provisions of this Order, as a parking place for vehicles without restriction in the length of time for which it parks and without displaying any parking disc or permit.
5. Save as provided in Article 23, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait on any day in any parking place specified in **Schedule 1:-**
- (1) for a longer period than 10 minutes; or
- (2) if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road.
- 5A. Save as provided in Article 23, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or

permit any vehicle to wait, at any time, on any day, in the lengths of road or sides of road specified in **Schedule 1A**:-

- (a) for a longer period than two hours; or
- (b) if a period of less than two hours have elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road.

6. Save as provided in Article 23, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait between the hours of 8.00 am and 6.00 pm on any day other than a Sunday, in the lengths of road or sides of road specified in **Schedule 2**:-

- (1) for a longer period than two hours; or
- (2) if a period of less than two hours has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road.

7. (1) Save as provided in Article 23, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait between the hours of 8.00 am and 6.00 pm on any day other than a Sunday, in the lengths of road or sides of road specified in **Schedule 3**:-

- (a) for a longer period than one hour; or
- (b) if a period of less than two hours has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road.

(2) Save as provided in Article 23, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait between the hours of 8.00 am and 6.00 pm on any day other than a Sunday, in the lengths of road or sides of road specified in **Schedule 4**:-

- (a) for a longer period than two hours; or
- (b) if a period of less than four hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road.

(3) Save as provided in Article 23, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait:-

between the hours of 8.00 am and 6.00 pm on any day, in the lengths of road or sides of road specified in **Schedule 5**:-

- (a) for a longer period than two hours; or
- (b) if a period of less than two hours has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road;

or between the hours of 6.00 pm and 8.00 am on any day:-

- (c) for a longer period than four hours; or
  - (d) if a period of less than two hours has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road.
- (4) Save as provided in Article 23, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait between the hours of 8.00 am and 6.00 pm on any day other than a Sunday, in the lengths of road or sides of road specified in **Schedule 6**:-
- (a) for a longer period than one hour; or
  - (b) if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road.
- (5) Save as provided in Article 23A, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait at any time, on any day, in the lengths of road or sides of road specified in **Schedule 6A**
- (6) Save as provided in Article 23A, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait between the hours of 8.00 am and 6.00 pm on any day other than a Sunday, in the lengths of road or sides of road specified in **Schedule 6B**
- (7) Save as provided in Article 23, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait between the hours of 8.00 am and 6.00 pm on any day other than a Sunday, in the lengths of road or sides of road specified in **Schedule 6C**:-
- (a) for a longer period than 30 minutes; or
  - (b) if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road.
- (8) Save as provided in Article 23, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil

Enforcement Officer, cause or permit any vehicle to wait at any time, in the lengths of road or sides of road specified in **Schedule 6D**:-

- (a) for a longer period than 10 minutes; or
  - (b) if a period of less than one hour has elapsed since the termination during the said 10 minutes of the last period of waiting (if any) by that vehicle on the same length of road.
- (9) Save as provided in Article 23, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait between the hours of 8.00 am and 6.00 pm on any day other than a Sunday, in the lengths of road or sides of road specified in **Schedule 6E**:-
- (a) for a longer period than 10 minutes; or
  - (b) if a period of less than one hour has elapsed since the termination during the said 10 minutes of the last period of waiting (if any) by that vehicle on the same length of road.
- (10) Save as provided in Article 23, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait between the hours of 8.00 am and 9.00 am and/or between the hours of 3.00 pm and 5.00 pm, on School Days only, in the lengths of road or sides of road specified in **Schedule 6F**:-
- (a) for a longer period than 30 minutes; or
  - (b) if a period of less than one hour has elapsed since the termination during the said 30 minutes of the last period of waiting (if any) by that vehicle on the same length of road.
- (11) Save as provided in Article 23, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait between the hours of 8.00 am and 5.00 pm on School Days only, in the lengths of road or sides of road specified in **Schedule 6G**
- (a) for a longer period than 30 minutes; or
  - (b) if a period of less than one hour has elapsed since the termination during the said 30 minutes of the last period of waiting (if any) by that vehicle on the same length of road.
- (12) Save as provided in Article 23, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait between the hours of 8.00 am and 5.00 pm on School Days only, in the lengths of road or sides of road specified in **Schedule 6H**:-

- (a) for a longer period than 10 minutes; or
- (b) if a period of less than one hour has elapsed since the termination during the said 10 minutes of the last period of waiting (if any) by that vehicle on the same length of road.

(13) Save as provided in Articles 23(a) to 23(i) inclusive, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait, between 8 am and 6 pm on any day, in the lengths of road or sides of road specified in **Schedule 6I** to this Order: -

- (a) For a longer period than 20 minutes; or
- (b) If a period of less than 40 minutes has elapsed since the termination during the said 20 minutes of the last period of waiting (if any) by that vehicle on the same length of road.

(14) Save as provided in Articles 23(a) to 23(i) inclusive, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait, between 11 am and 6 pm, on any day, in the lengths of road or sides of road specified in **Schedule 6J** to this Order: -

- (a) For a longer period than 20 minutes; or
- (b) If a period of less than 40 minutes has elapsed since the termination during the said 20 minutes of the last period of waiting (if any) by that vehicle on the same length of road.

8. The driver of a vehicle shall not permit it to wait in a parking place specified in Schedules 1 to 6K inclusive to this order during the prescribed hours, unless the vehicle is:-

- (a) of a class specified in Article 4 of this Order, and
- (b) wholly within the limits of the parking place as marked on the carriageway by broken white lines conforming to diagram 1028.4 in Schedule 6 to the 1994 Regulations and is parked parallel to the kerb with the near side of the vehicle adjacent to the edge of the carriageway or in the case of a vehicle waiting on the right-hand side of a one-way street is parked parallel to the kerb with the offside of the vehicle adjacent to the edge of the carriageway or wholly within the limits of the parking place as marked on the highway by broken white lines conforming to diagram 1028.4 in Schedule 6 to the 1994 Regulations.

9. The driver of a motor vehicle shall not use a parking place

- (a) so as unreasonably to prevent access to any premises adjoining the road, or the use of the road by other persons, or so as to be a nuisance;
- (b) when closed under the provisions of Article 12 of this Order.

10. The driver of a motor vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place, and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place.
11. No person shall use a vehicle, while it is in a parking place, in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services.
12. Nothing in Article 8 of this Order shall restrict the power of the Council or of the District Council for preventing obstruction of the streets by order on the occasion of any public procession rejoicing or illumination, or where the streets are thronged or liable to be obstructed, to close any parking place.

### **Display of Parking Discs**

13. (1) Subject to the provisions of Article 19 of this Order the driver of a vehicle shall on the arrival of the vehicle at a parking place specified in Schedule 5 to this Order during the period of waiting within the prescribed hours, exhibit on the vehicle in accordance with the following provisions of this Article a parking disc.
  - (2) The parking disc shall be exhibited on the vehicle
    - (a) in the case of a two wheeled motor cycle having a side car attached thereto, or an invalid carriage, in a conspicuous position on the near side of the vehicle in front of the driving seat, and
    - (b) in the case of all other vehicles, in the relevant position defined in Article 2 above.
  - (3) The parking disc while exhibited on the vehicle shall be so placed that the time of arrival shown on the front of the said disc is clearly visible to a person standing on the near side of the vehicle.
14. When a parking disc has been displayed in a vehicle in accordance with the provisions of Article 13 of this order, no person shall remove the certificate or parking disc from the vehicle unless authorised to do so by the driver of the vehicle.
15. The driver of a vehicle shall on exhibiting the parking disc on the vehicle in accordance with the provisions of Article 13 set the disc so that it indicates the quarter of an hour period during which the vehicle arrived at the parking place.
16. Where a vehicle having been left on a side of road remains there at the beginning of the prescribed hours then the vehicle shall be treated as if it had arrived in the parking place at the beginning of those hours.
17. (1) Subject to the provisions of Article 19 of this Order the driver of a vehicle shall not permit it to wait continuously in a parking place specified in:-



- (a) Schedule 5 to this Order between the hours of 8.00 am and 6.00pm, on any day:-
    - (i) for a longer period than two hours, such period of two hours being calculated as commencing from the later time indicated on the parking disc, set in accordance with the provisions of Article 15; or
    - (ii) if a period of less than two hours has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road; or
  - (b) Schedule 5 to this Order between the hours of 6.00 pm and 8.00 am the following day, on any day:-
    - (i) for a longer period than four hours, such period of four hours being calculated as commencing from the later time indicated on the parking disc, set in accordance with the provisions of Article 15; or
    - (ii) if a period of less than two hours has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle on the same length of road;; or
- (2) When a parking disc exhibited in pursuance of Article 13 of this Order on a vehicle waiting in a parking place is showing the quarter of an hour period, the later time indicated by the disc showing the end of that period shall be treated as evidence that the vehicle has been waiting in that parking place since that later time in any proceedings for a contravention of paragraph (1) of this Article.

18. When a vehicle has left a parking place specified in

- (1) Schedule 5 of this Order after waiting thereon the driver thereof shall not return within four hours after its leaving and permit it to wait again upon that parking place during the hours of 8.00 am and 6.00 pm on any day;
- (2) Schedule 5 of this Order after waiting thereon the driver thereof shall not within two hours return after its leaving and permit it to wait again upon that parking place during the hours of 6.00 pm and 8.00 am on any day;

19. (1) The driver of a two wheeled motor cycle not having a sidecar attached thereto shall be exempt from the provisions of Article 13 of this Order.
- (2) A disabled persons' vehicle which displays, in accordance with Article 2 above, in the relevant position a disabled persons' badge shall be exempt, during the prescribed hours, from compliance with any limitation of time during which a vehicle may be left in a parking place specified in the foregoing provisions of this Order.

20. No person shall:

- (a) after the parking disc exhibited on the vehicle has been set in accordance with Article 15 of this Order, alter the indications given by that parking disc whilst the said vehicle remains in the parking place; or
  - (b) knowingly exhibit on any vehicle any parking disc which has been altered, defaced, mutilated or added to or upon which the figures or particulars have become illegible.
21. (1) Subject to the proviso hereto, where a police officer in uniform or a Civil Enforcement Officer is of the opinion that any of the provisions contained in Articles 8, 13, 15, 17, 17 or 20 of this Order have been contravened or not complied with in respect of a vehicle left in a parking place, he may remove or cause to be removed the vehicle from the parking place and, where it is so removed he shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle.
- (2) Provided that when a vehicle is waiting in a parking place in contravention of the provisions of Article 8(b) of this Order, a person authorised in that behalf by the Council may alter or cause to be altered the position of the vehicle in order that its position shall comply with that provision.
22. Any person removing a vehicle or altering its position by virtue of the last preceding Article may do so by towing or driving the vehicle or in such other manner as he may think necessary and may take such measures in relation to the vehicle as he may think necessary to enable him to remove it or alter its position as the case may be.

### **Exemptions**

23. Nothing in the foregoing provisions of this part of the Order shall apply to a vehicle waiting during the prescribed hours in a parking place specified in Schedules 1 to 6J inclusive to this Order if the vehicle is
- (a) waiting only so long as is necessary to enable a person to board or alight from the vehicle or to enable goods or merchandise to be loaded onto or unloaded from the vehicle;
  - (b) waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;
  - (c) a vehicle used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties;
  - (d) waiting to enable it to be used in connection with the removal of any obstruction to traffic;
  - (e) in the service of or employed by the Post Office and is waiting while postal packets addressed to premises adjacent to the parking place in which the vehicle is waiting are being unloaded from the vehicle, or, having been

unloaded therefrom, or are being delivered or while postal packets are being collected from premises or posting boxes adjacent to the parking place in which the vehicle is waiting or is in use in connection with the servicing of posting boxes adjacent to the parking place in which the vehicle is waiting;

- (f) being used by a statutory undertaker or its contractor in connection with any building operation or demolition, the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration or repair in or near the said parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act, 1984;
- (g) in actual use in connection with the removal of furniture from one office or dwellinghouse to another or the removal of furniture from such premises to a depository or to such premises from a depository;
- (h) in actual use in connection with the removal of a coffin containing the remains of a deceased person to or from premises situate on or adjacent to that parking place;
- (i) if goods are being sold or offered or exposed for sale from a vehicle by a person who is licensed by a local authority to sell goods from a stationary vehicle on a pitch situated in a parking place;
- (j) displaying in the relevant position a valid disabled person's badge or resident's permit or waiver.

23A. Nothing in Articles 7(5) and 7(6) of this Order shall apply to a vehicle waiting during the prescribed hours in a parking place specified in Schedules 6A and 6B to this Order if the vehicle is: -

- (a) waiting only so long as is necessary to enable a person to board or alight from the vehicle or to enable goods or merchandise to be loaded onto or unloaded from the vehicle;
- (b) waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;
- (c) a vehicle used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties;
- (d) waiting to enable it to be used in connection with the removal of any obstruction to traffic;
- (e) in the service of or employed by the Post Office and is waiting while postal packets addressed to premises adjacent to the parking place in

which the vehicle is waiting are being unloaded from the vehicle, or, having been unloaded therefrom, or are being delivered or while postal packets are being collected from premises or posting boxes adjacent to the parking place in which the vehicle is waiting or is in use in connection with the servicing of posting boxes adjacent to the parking place in which the vehicle is waiting;

- (f) being used by a statutory undertaker or its contractor in connection with any building operation or demolition, the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration or repair in or near the said parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act, 1984;
- (g) in actual use in connection with the removal of furniture from one office or dwellinghouse to another or the removal of furniture from such premises to a depository or to such premises from a depository;
- (h) in actual use in connection with the removal of a coffin containing the remains of a deceased person to or from premises situate on or adjacent to that parking place;
- (i) if goods are being sold or offered or exposed for sale from a vehicle by a person who is licensed by a local authority to sell goods from a stationary vehicle on a pitch situated in a parking place;
- (j) displaying in the relevant position a valid resident's permit.

### **PART III**

#### **PROHIBITION OF WAITING**

24. Save as provided in Article 25 of this Order, no person shall except upon the direction or with the permission of a police constable in uniform, or of a Civil Enforcement Officer, cause or permit any vehicle to wait:-

- (1) at any time in the lengths of road or the sides of road specified in **Schedule 7** of this Order;
- (2) between the hours of 8.00 am and 5.00 pm on a Monday to Friday inclusive in the lengths of road or sides of road specified in **Schedule 8** to this Order;
- (3) between the hours of 8.00 am and 6.00 pm on any day other than a Sunday in the lengths of road or sides of road specified in **Schedule 9** of this Order;
- (4) between the hours of 8.00 am and 6 pm on a Monday to Friday inclusive in the lengths of road or sides of road specified in **Schedule 10** of this Order;

- (5) between the hours of 8.00 am and 9.00 am and between 3.00 pm and 5.00 pm on a Monday to Friday inclusive in the lengths of road or sides of road specified in **Schedule 11** of this Order;
- (6) between the hours of 8.30 am and 9.15 am and between 2.45 pm and 3.45 pm on any School Day in the lengths of road or sides of road specified in **Schedule 12** of this Order;
- (6) between the hours of 8.00 am and 8.00 pm on any day in the lengths of road or sides of road specified in **Schedule 13** of this Order;
- (7) between the hours of 8.30 am and 9.15 am and between 2.45 pm and 3.45 pm on a Monday to Friday inclusive, in the lengths of road or sides of road specified in **Schedule 14** of this Order;
- (8) between the hours of 8.00 am and 9.00 am and between 2.00 pm and 4.00 pm on a Monday to Friday inclusive, in the lengths of road or sides of road specified in **Schedule 14A** of this Order;
- (9) between the hours of 8.00 am and 9.00 am and between the hours of 3.00 pm and 5.00 pm, on School Days only, in the lengths of road or sides of road specified in **Schedule 14B** to this Order;
- (10) between the hours of 8 am and 10 am and between 12 noon and 2 pm, on a Monday to Friday inclusive, in the lengths of road or sides of road specified in **Schedule 14C** of this Order;
- (11) between the hours of 10 am and 12 pm and between 2 pm and 4 pm, on a Monday to Friday inclusive, in the lengths of road or sides of road specified in **Schedule 14D** to this Order;

### **Exemptions**

25. (1) Nothing in Articles 24(1) to 24(11) inclusive of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc (on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began) to wait in the lengths of road or on the sides of road referred to in the said Articles for a period not exceeding three hours (not being a period separated by an interval of less than one hour from the previous period of waiting by the same vehicle in the same length of road or on the same side of road on the same day).

Provided that this paragraph shall not apply to such lengths or sides of road specified in the said Schedules during such times as loading and unloading restrictions are in force.

26. Nothing in Articles 24(1) to (11) shall render it unlawful for a person to cause or permit a vehicle to wait in the lengths or road or sides of road specified therein if the vehicle is:-

- (a) waiting only so long as is necessary to enable a person to board or alight from the vehicle or to enable goods or merchandise to be loaded onto or unloaded from the vehicle;
- (b) waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;
- (c) a vehicle used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties;
- (d) waiting to enable it to be used in connection with the removal of any obstruction to traffic;
- (e) in the service of or employed by the post office and is waiting while postal packets addressed to premises adjacent to the parking place in which the vehicle is waiting are being unloaded therefrom, or are being delivered or while postal packets are being collected from the premises or posting boxes adjacent to the parking place in which the vehicle is waiting, or, is in use in connection with the serving of posting boxes adjacent to the parking place in which the vehicle is waiting;
- (f) being used in connection with any building operation or demolition the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration or repair in or near the said parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984;
- (g) in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from depository;
- (h) in actual use in connection with the removal of a coffin containing the remains of a deceased person to or from premises situated on or adjacent to that parking place.

27. Nothing in the foregoing provisions of this Order shall apply at a bus stop to a public service vehicle providing a local service, as defined in Section 2 of the Transport Act 1985, provided that the Highway Authority or its agent has agreed in writing that the bus stop is a suitable place at which such vehicles may wait for no longer than is necessary to take up or set down passengers.

## **PART IV**

### **AUTHORISATION AND USE OF DISABLED PERSON'S PARKING PLACE**

#### **Disabled Persons' Parking Place – At Any Time – Waiting Limited to 3 Hours, Return Prohibited within 1 Hour**

28. (1) That part of the road specified in **Schedule 15** to this Order is authorised to be used at any time subject to Articles 29 and 30 of this Order as a parking place for a valid disabled person's vehicle which displays a disabled person's badge in a relevant position for a period not exceeding three hours, providing that, where a vehicle has left a parking place specified in Schedule 15 of this Order after waiting thereon the driver thereof shall not within 1 hour after its leaving permit it to wait again upon that parking place.

#### **Disabled Persons' Parking Place – 8.00 am – 6.00 pm, Monday – Saturday, Waiting Limited to 2 Hours, Return Prohibited within 2 Hours**

- (2) That part of the road specified in **Schedule 15A** to this Order is authorised to be used between the hours of 8.00 am and 6.00 pm, on a Monday to Saturday inclusive, subject to Articles 29 and 30 of this Order as a parking place for a valid disabled person's vehicle which displays a disabled person's badge in a relevant position for a period not exceeding two hours, providing that, where a vehicle has left a parking place specified in Schedule 15A of this Order after waiting thereon the driver thereof shall not within 2 hours after its leaving permit it to wait again upon that parking place.
29. For the avoidance of doubt, the driver of a vehicle shall not permit it to wait in the parking place specified in Schedules 15 and 15A to this Order unless the vehicle is
- (a) a disabled person's vehicle which displays a disabled persons badge in a relevant position;
  - (b) is wholly within the limits of the parking place as indicated by the markings on the carriageway.

#### **Exemptions**

30. (1) Nothing in Article 28 of this order shall restrict the power of the Council or of the District Council for preventing obstruction of the street by Order on the occasion of any public procession rejoicing or illumination or where the street is thronged or liable to be obstructed to close the parking places specified in Schedules 15 and 15A to this Order.
- (2) Nothing in Article 28 of this order shall render it unlawful for a vehicle to wait on the lengths of road or sides of road specified therein:-
- (a) if it is being used for Police, Fire Brigade or Ambulance purposes;
  - (b) if its being used by statutory undertakers or their contractors in connection with any building operation or demolition, the

maintenance, improvement or construction of the parking place or the laying, erection, alteration or repair in or near the parking place of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984.

- (c) waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;
- (d) if its is being used in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties;
- (e) waiting to enable it to be used in connection with the removal of any obstruction to traffic;
- (f) if goods are being sold or offered or exposed for sale from a vehicle by a person who is licensed by a local authority to sell goods from a stationary vehicle on a pitch situated in a parking place.

## **PART V**

### **PROHIBITION OF LOADING/UNLOADING**

- 31. Save as provided in Article 37 to this Order, no person shall cause or permit any vehicle to wait at any time, or to load/unload, at any time, in the lengths of road or sides of road specified in **Schedule 16** to this Order for the purpose of loading or unloading.
- 32. Save as provided in Article 37 to this Order, no person shall cause or permit any vehicle to wait between the hours of 10.00 am and 4.00 pm on any day other than a Sunday, in the lengths of road or sides of road specified in **Schedule 17** to this Order for the purpose of loading or unloading.

### **Exemptions**

- 33. Nothing in Articles 31 or 32 to this Order shall apply so as to render it unlawful for a person to cause or permit a vehicle to wait in the lengths of road specified therein if the vehicle is:-
  - (a) being used by statutory undertakers or their contractors in connection with any building operation or demolition the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration or repair in or near the said parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984;
  - (b) waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;



- (c) being used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties;
  - (d) if the vehicle is in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository; or
  - (e) if the vehicle is being used for other exceptional loading or unloading purposes.
34. In accordance with Regulation 3 of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 2000 (SI No. 683), the restrictions specified in Articles 31 and 32 of this Order shall not apply to a goods vehicle which displays in the relevant position a disabled person's badge.

## **PART VI**

### **PROVISION OF PARKING PLACES FOR BUSES ONLY**

35. Save as provided in Article 36 of this Order no person shall except upon the direction of a Police Constable in uniform or of a Civil Enforcement Officer cause or permit any vehicle other than a coach to wait in the lengths or road or sides of road specified in **Schedule 18** to this Order.

#### **Exemptions**

36. Nothing in Article 35 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of road or sides of road referred to therein if the vehicle is:-
- (a) waiting only so long as is necessary to enable a person to board or alight from the vehicle or to enable goods or merchandise to be loaded onto or unloaded from the vehicle;
  - (b) waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;
  - (c) a vehicle used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties;
  - (d) waiting to enable it to be used in connection with the removal of any obstruction to traffic;
  - (e) being used by statutory undertakers or their contractors in connection with the laying erection alteration or repair in or in land adjacent to that length of road of any sewer or of any main pipe or apparatus for the supply of water

gas or electricity or of any telecommunications apparatus as defined in Schedule 2 of the Telecommunications Act 1984;

## **PART VII**

### **PROVISION OF PARKING PLACES FOR LIFEBOAT VEHICLES ONLY**

37. No person shall except upon the direction of a Police Constable in uniform or a Civil Enforcement Officer cause or permit any vehicle, other than a vehicle being used in the service of the Royal National Lifeboat Institute, to wait at any time in the lengths of road or sides of road specified in **Schedule 19** to this Order.

## **PART VIII**

### **PROVISION OF PARKING PLACES FOR DOCTORS VEHICLES ONLY**

38. No person shall except upon the direction of a Police Constable in uniform or a Civil Enforcement Officer cause or permit any vehicle, other than General Practitioner's vehicles, to wait at any time in the lengths of road or sides of road specified in **Schedule 20** to this Order.

## **PART VIIIA**

### **PARKING PLACE FOR HEAVY COMMERCIAL VEHICLES EXCEEDING 7.5 TONNES MAXIMUM GROSS WEIGHT ONLY.**

- 38A. Save as provided in Article 38B, no person shall except upon the direction of a Police Constable in uniform or of a civil enforcement officer, cause or permit any vehicle, other than a heavy commercial vehicle exceeding 7.5 tonnes maximum gross weight, to wait at any time, on any day, in the lengths of road or sides of road specified in **Schedule 21** to this Order.

#### **Exemptions**

- 38B. Nothing in Article 38A to this Order shall apply so as to render it unlawful for a person to cause or permit a vehicle to wait in the lengths of road specified therein if the vehicle is:-
- (a) being used by statutory undertakers or their contractors in connection with any building operation or demolition the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration or repair in or near the said parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984;

- (b) Waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;
- (c) being used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties;
- (d) if the vehicle is in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository; or
- (e) If the vehicle is being used for other exceptional loading or unloading purposes.

## **PART IX**

### **PROVISION OF LOADING ONLY PARKING PLACES - AT ALL TIMES**

39. (1) Each of the lengths of road specified in **Schedule 22** to this Order are designated as a loading only parking place.
- (2) Save as provided in Article 40 to this Order, no person shall, except upon the direction of a police constable or Civil Enforcement Officer, cause or permit any vehicle to wait in those lengths of road specified in Schedule 22 unless goods are being loaded or unloaded from the said vehicle.

### **Exemptions**

40. Nothing in Articles 37 to 39 shall render it unlawful to cause or permit any vehicle to wait in the lengths of road referred to therein for so long as may be necessary to enable:-
- (i) a person to board or alight from the vehicle;
  - (ii) the vehicle, if it cannot conveniently use another road for such purposes to be used in connection with the following operations:-
    - (a) Building and demolition work;
    - (b) The removal of any obstruction to traffic from the highway;
    - (c) The maintenance, improvement or reconstruction of any of those lengths of road;
    - (d) The laying, erection, alteration or repair of any sewer or main pipe or apparatus for the supply of gas water or electricity or of any

telecommunications apparatus in or on any land adjacent to any of those lengths of road;

- (iii) The user of the vehicle if he is employed in the services of a Local Authority or a water undertaker and is acting in pursuance of that authority's statutory powers or duties to carry out those powers or duties;
- (iv) the vehicle to be used in connection with the delivery or collection of postal packets as defined by Section 125 of the Postal Services Act 2000;
- (v) any vehicle to wait at or near to any premises situated on or adjacent to any of those lengths of road for so long as is reasonably necessary where that vehicle is being used in connection with a wedding or funeral;
- (vi) the vehicle to be used for Ambulance, Fire Brigade or Police purposes;
- (vii) goods to be loaded or unloaded from the vehicle;

## **PART X**

### **PROVISION OF LOADING ONLY PARKING PLACES**

41. (1) Each of the lengths of road specified in **Schedule 23** to this Order are designated as a loading only parking place between the hours of 8.00 am and 6.00 pm, Monday to Saturday inclusive.
- (2) Each of the lengths of road specified in **Schedule 23A** to this Order are designated as a loading only parking place between the hours of 6.00 am and 11.00 am, Monday to Sunday inclusive
- (3) Save as provided in Article 42 to this Order, no person shall, except upon the direction of a police constable or civil enforcement officer, cause or permit any vehicle to wait in those lengths of road specified in Schedules 23 and 23A unless goods are being loaded or unloaded from the said vehicle.

### **Exemptions**

42. Nothing in Article 41 shall render it unlawful to cause or permit any vehicle to wait in the lengths of road referred to therein for so long as may be necessary to enable:-
- (i) a person to board or alight from the vehicle;
  - (ii) the vehicle, if it cannot conveniently use another road for such purposes to be used in connection with the following operations:-
    - (a) Building and demolition work;
    - (b) The removal of any obstruction to traffic from the highway.

- (c) The maintenance, improvement or reconstruction of any of those lengths of road.
- (d) The laying, erection, alteration or repair of any sewer or main pipe or apparatus for the supply of gas water or electricity or of any telecommunications apparatus in or on any land adjacent to any of those lengths of road;
- (iii) The user of the vehicle if he is employed in the services of a Local Authority or a water undertaker and is acting in pursuance of that authority's statutory powers or duties to carry out those powers or duties;
- (iv) the vehicle to be used in connection with the delivery or collection of postal packets as defined by Section 125 of the Postal Services Act 2000;
- (v) any vehicle to wait at or near to any premises situated on or adjacent to any of those lengths of road for so long as is reasonably necessary where that vehicle is being used in connection with a wedding or funeral;
- (vi) the vehicle to be used for Ambulance, Fire Brigade or Police purposes;
- (vii) goods to be loaded or unloaded from the vehicle.

## **PART XI**

### **RESTRICTION OF STOPPING ON SCHOOL “KEEP CLEAR” MARKINGS**

43. (1) Save as provided in Article 44 of this Order, no person shall, except upon or with the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer, cause or permit any vehicle to stop or remain at rest between the hours of 8.00 am and 5.00 pm, Monday to Friday inclusive, in the lengths of road or sides of road specified in **Schedule 24** to this Order.
- (2) Save as provided in Article 44 of this Order, no person shall, except upon or with the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer, cause or permit any vehicle to stop or remain at rest between the hours of 8.00 am and 5.00 pm on School Days, in the lengths of road or sides of road specified in **Schedule 25** to this Order.

### **Exemptions**

44. (1) Nothing in Article 43 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of road or sides or road referred to therein for so long as may be necessary:-
- (a) to enable waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;
  - (b) if the vehicle is being used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service

of a local authority or water authority which is being used in pursuance of statutory powers or duties;

- (c) to enable it to be used in connection with the removal of any obstruction to traffic;
- (d) if the vehicle is being used in the service of or employed by the post office and is waiting while postal packets addressed to premises adjacent to the parking place in which the vehicle is waiting are being unloaded from the vehicle, or, having been unloaded therefrom, or are being delivered or while postal packets are being collected from premises or posting boxes adjacent to the parking place in which the vehicle is waiting, or, is in use in connection with the servicing of posting boxes adjacent to the parking place in which the vehicle is waiting;
- (e) if the vehicle is being used by statutory undertakers or their contractors in connection with any building operation or demolition, the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration or repair in or near the said parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act, 1984;
- (f) if the vehicle is in actual use in connection with the removal of a coffin containing the remains of a deceased person to or from premises situated on or adjacent to that parking place.
- (g) if the vehicle is adapted to carry more than 8 passengers and is a school bus waiting so long as to enable children to board or alight from the vehicle.

## PART XII

### PROHIBITION OF STOPPING - EXCEPT FOR HACKNEY CARRIAGES

- 45. The lengths of road specified in **Schedule 26** to this Order have been designated by Barrow Borough Council under section 63 of The Local Government (Miscellaneous Provisions) Act 1976, as hackney carriage stands, at any time, on any day.
- 45A. The lengths of road specified in **Schedule 26A** to this Order have been designated by Barrow Borough Council under section 63 of The Local Government (Miscellaneous Provisions) Act 1976, as hackney carriage stands, between the hours of 8 am and 6 pm, on a Monday to Sunday inclusive.
- 45B. The lengths of road specified in **Schedule 26B** to this Order have been designated by Barrow Borough Council under section 63 of The Local Government (Miscellaneous Provisions) Act 1976, as hackney carriage stands, between the hours of 6 pm and midnight and between midnight and 8 am, on a Monday to Sunday inclusive.

## **Exemptions**

46. Nothing in Articles 45, 45A or 45B of this Order shall render it unlawful to cause or permit a vehicle to wait in those lengths of road specified in Schedule 26 to 26B inclusive of this Order at any time for so long as may be necessary to enable the vehicle, if it cannot conveniently use another road for such purposes, to be used in connection with the following operations:-
- (i) Building and demolition work;
  - (ii) The removal of any obstruction to traffic from the highway;
  - (iii) The maintenance, improvement or reconstruction of any of those lengths of road;
  - (iv) The laying, erection, alteration or repair of any sewer or main pipe or apparatus for the supply of gas water or electricity or of any telecommunications apparatus in or on any land adjacent to any of those lengths of road;
  - (v) The user of the vehicle if he is employed in the services of a Local Authority or a water undertaker and is acting in pursuance of that authority's statutory powers or duties to carry out those powers or duties;
  - (vi) if the vehicle to be used in connection with the delivery or collection of postal packets as defined by Section 125 of the Postal Services Act 2000;
  - (v) Any vehicle to wait at or near to any premises situated on or adjacent to any of those lengths of road for so long as is reasonably necessary where that vehicle is being used in connection with a wedding or funeral;
  - (vi) The vehicle is to be used for Ambulance, Fire Brigade or Police purposes;
  - (vii) If the vehicle is a public service vehicle; or
  - (viii) In relation to a vehicle waiting when the person in control of it:-
    - (a) is required by law to stop, or
    - (b) is obliged to stop in order to avoid an accident, or
    - (c) is prevented from proceeding by circumstances outside his control;
  - (ix) If the vehicle is a Hackney Carriage licensed by the Council.

## **PART XIII**

### **PROHIBITION OF STOPPING - AT ALL TIMES (EXCEPT FOR BUSES)**

47. Save as provided in Article 48 of this Order, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle other than a bus to stop or remain at rest at any time in those lengths of road specified in **Schedule 27** to this Order.

### **Exemptions**

48. Nothing in Article 47 of this Order shall render it unlawful to cause or permit a vehicle to wait in those lengths of road specified in Schedule 27 of this Order at any time for so long as may be necessary to enable the vehicle, if it cannot conveniently use another road for such purposes, to be used in connection with the following operations:-
- (i) Building and demolition work;
  - (ii) The removal of any obstruction to traffic from the highway;
  - (iii) The maintenance, improvement or reconstruction of any of those lengths of road;
  - (iv) The laying, erection, alteration or repair of any sewer or main pipe or apparatus for the supply of gas water or electricity or of any telecommunications apparatus in or on any land adjacent to any of those lengths of road;
  - (v) The user of the vehicle if he is employed in the services of a Local Authority or a water undertaker and is acting in pursuance of that authority's statutory powers or duties to carry out those powers or duties;
  - (vi) if the vehicle to be used in connection with the delivery or collection of postal packets as defined by Section 125 of the Postal Services Act 2000;
  - (v) Any vehicle to wait at or near to any premises situated on or adjacent to any of those lengths of road for so long as is reasonably necessary where that vehicle is being used in connection with a wedding or funeral;
  - (vi) The vehicle is to be used for Ambulance, Fire Brigade or Police purposes;
  - (vii) If the vehicle is a public service vehicle; or
  - (viii) In relation to a vehicle waiting when the person in control of it:-
    - (a) is required by law to stop, or
    - (b) is obliged to stop in order to avoid an accident, or
    - (c) is prevented from proceeding by circumstances outside his control;
  - (ix) If the vehicle is a public service vehicle.

### **PART XIV**



## **PROHIBITION OF DRIVING**

### **At All Times - All Motor Vehicles (No exemptions)**

49. No person shall cause any motor vehicle to proceed along the roads or lengths of road specified in **Schedule 28** of this Order.

### **At All Times - All Motor Vehicles (Except for Access)**

50. Save as provided in Article 51 of this Order, no person shall cause any motor vehicle to proceed along the roads or lengths of road specified in **Schedule 29** of this Order.

### **Exemptions**

51. Nothing in Article 50 of this Order shall apply so as to prevent any person from causing any vehicle to proceed along the road or lengths of road specified therein if the vehicle is being used:-
- (i) for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to that length of road; or
  - (b) in connection with any building operation or demolition in or adjacent to that length of road, the removal of any obstruction to traffic in that length of road, the maintenance, improvement or reconstruction of that length of road, or the laying, erection, alteration or repair in or adjacent to that length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telegraphic lines or traffic sign;
  - (c) any emergency being dealt with by the Police, Fire or Ambulance Service.

### **At All Times - All Vehicles**

52. Save as provided in Article 54 of this Order, no person shall cause or permit any vehicle to enter or proceed in any of the lengths of road specified in **Schedule 30** of this Order.

### **At All Times - Except Heavy Goods Vehicles and Armoured Security Vehicles**

53. Save as provided in Article 54 of this Order, no person shall cause any vehicle, other than a heavy goods vehicle or an armoured security vehicle used in connection with a bank or building society for delivery/collection to proceed along any of the lengths of road specified in **Schedule 31** of this Order.

### **Exemptions**

54. Nothing in Articles 52 and 53 of this Order shall apply so as to prevent any person from causing any vehicle to proceed along those roads referred to therein so long as that vehicle is necessarily being used for:-
- (i) any building or demolition operations in or adjacent to that part of road;

- (ii) the removal of any obstruction to traffic from that part of road;
- (iii) the maintenance, improvement or reconstruction of that part of road; or
- (iv) the laying erection alteration or repair in or adjacent to that part of road of any sewer or of any main pipe or apparatus for the supply of gas water or electricity or of any telegraphic lines or traffic sign or telecommunication apparatus;
- (v) any emergency being dealt with by the Police, Fire or Ambulance Service.

### **At All Times - Except for Loading or Unloading**

55. Save as provided in Article 56 of this Order, no person shall cause any motor vehicle to proceed along the roads or lengths of road specified in **Schedule 32** of this Order.

### **Exemptions**

56. Nothing in Article 55 of this Order shall apply so as to prevent any person from causing any vehicle to proceed along those roads referred to therein so long as that vehicle is necessarily being used for:-

- (i) any building or demolition operations in or adjacent to that part of road;
- (ii) the removal of any obstruction to traffic from that part of road;
- (iii) the maintenance, improvement or reconstruction of that part of road; or
- (iv) the laying erection alteration or repair in or adjacent to that part of road of any sewer or of any main pipe or apparatus for the supply of gas water or electricity or of any telegraphic lines or traffic sign or telecommunication apparatus;
- (v) any emergency being dealt with by the Police, Fire or Ambulance Service;
- (vi) the purpose of loading or unloading goods to or from the vehicle to or from premises situated on or adjacent to that length of road.

### **At All Times - All Vehicles Over 7.5 Tonnes Maximum Gross Weight**

57. Save as provided in Article 58 of this Order, no person shall cause any motor vehicle, the maximum gross weight of which exceeds 7.5 tonnes, to proceed along the roads or lengths of road specified in **Schedule 33** of this Order.

### **Exemptions**

58. Nothing in Article 57 of this Order shall apply so as to prevent any person from causing any vehicle to proceed along those roads referred to therein so long as that vehicle is necessarily being used for:-

- (i) any building or demolition operations in or adjacent to that part of road;
- (ii) the removal of any obstruction to traffic from that part of road;
- (iii) the maintenance, improvement or reconstruction of that part of road; or
- (iv) the laying erection alteration or repair in or adjacent to that part of road of any sewer or of any main pipe or apparatus for the supply of gas water or electricity or of any telegraphic lines or traffic sign or telecommunication apparatus;
- (v) any emergency being dealt with by the Police, Fire or Ambulance Service;
- (vi) for the conveyance of persons, goods or merchandise to or from premises situated on or adjacent to that length of road.

**At All Times - All Vehicles Over 7.5 Tonnes Maximum Gross Weight (Except for Emergency Vehicles and Scheduled Local Service Buses)**

58A. Save as provided in Article 58B of this Order, no person shall cause any vehicle, the maximum gross weight of which exceeds 7.5 tonnes, to proceed along the roads or lengths of road specified in **Schedule 33A** of this Order.

**Exemptions**

58B. Nothing in Article 58A of this Order shall apply so as to prevent any person from causing any vehicle to proceed along those roads referred to therein so long as that vehicle is necessarily being used for:-

- (i) vehicles being used for police, fire brigade or ambulance purposes;
- (ii) public service vehicles providing a scheduled local bus service or
- (iii) vehicles being used for the removal of any obstruction to traffic from that part of the road, or the maintenance, improvement or reconstruction of that part of the road.

**Prohibition of Driving and Prohibition of Waiting - Except Market Trader Permit Holders**

59. Save as provided in Article 60 of this Order, no person shall cause any vehicle to wait at any time or to proceed along the lengths of road specified in **Schedule 34** of this Order between the hours of 7.30 am and 9.15 am and between 4.30 pm and 6.00 pm

**Exemptions**

60. Nothing in Article 59 of this Order shall apply so as to prevent any person from causing any vehicle to proceed along those roads referred to therein so long as that vehicle is necessarily being used for:-

- (i) Placing and maintaining in a parking place or in the vicinity of a parking place as appropriate, traffic signs of a size and/or colour and/or type prescribed by or authorised under Section 64 or the 1984 Act indicating that the parking place may be used for parking only by such vehicles as may be authorised to use it by virtue of this Order;
- (ii) to carry out any such work as is or may be reasonably necessary to facilitate the satisfactory operation of any parking place;
- (iii) any building or demolition operations in or adjacent to that part of road;
- (iv) the removal of any obstruction to traffic from that part of road;
- (v) the maintenance, improvement or reconstruction of that part of road;
- (vi) the laying erection alteration or repair in or adjacent to that part of road of any sewer or of any main pipe or apparatus for the supply of gas water or electricity or of any telegraphic lines or traffic sign or telecommunication apparatus; or
- (vii) market trading purposes and is displaying a valid permit in the relevant position.

### **Prohibition of Driving At Any Time (Except Permit Holders)**

60A. Save as provided in Articles 60B to 60Q inclusive to this Order, no person shall cause or permit any vehicle to proceed along the lengths of road specified in **Schedule 35** to this Order.

60B. Nothing in Article 60A to this Order shall apply so as to prevent any person from causing any vehicle to proceed along those roads referred to therein so long as that vehicle is necessarily being used for:-

- (i) Placing and maintaining in a parking place or in the vicinity of a parking place as appropriate, traffic signs of a size and/or colour and/or type prescribed by or authorised under Section 64 or the 1984 Act indicating that the parking place may be used for parking only by such vehicles as may be authorised to use it by virtue of this Order;
- (ii) to carry out any such work as is or may be reasonably necessary to facilitate the satisfactory operation of any parking place;
- (iii) any building or demolition operations in or adjacent to that part of road;
- (iv) the removal of any obstruction to traffic from that part of road;
- (v) the maintenance, improvement or reconstruction of that part of road;

- (vi) the laying erection alteration or repair in or adjacent to that part of road of any sewer or of any main pipe or apparatus for the supply of gas water or electricity or of any telegraphic lines or traffic sign or telecommunication apparatus; or
- (vii) market trading purposes and is displaying a valid permit in the relevant position.

### **Application for Exemption Permits**

60C. Any resident whose normal residence is in the street specified in column 3 of Schedule 35 to this Order and who is the owner or registered keeper of a vehicle, being either a passenger vehicle, goods vehicle, motor cycle with or without side car attachment, not exceeding 2.28m in height and 5.50m in length, may apply to the Council for the issue of an permit exempting them from the restriction specified in Article 60A to this Order.

60D. Any application made in accordance with the foregoing Article shall include such particulars as the Council may from time to time require.

60E. The Council may require an applicant for a permit to produce to an officer of the Council such evidence in support of their application as may be reasonably required by the Council to verify any particulars or information given to it by the applicant.

60F. Any resident who is unable to provide the Council with such information as it may reasonably require in connection with his application may apply to the Council for the issue of a visitors permit under the provisions of Article 60H.

60G. Residents permits are not transferable nor do they have any effect outside the street specified on that permit.

### **Issue of Permits**

60H. Upon receipt of an application for a permit made in accordance with Article 60C hereof the Council, upon being satisfied that the applicant is a resident and is either the owner or registered keeper of a vehicle referred to in his application, shall issue a permit for that vehicle to the applicant.

60I. A permit issued under the provisions of Article 60H shall allow the vehicle in respect of which the permit is issued to proceed in the length of road specified in Schedule 35 to this Order as the Council shall, at its discretion, think fit for the applicant's needs.

### **Application for Visitor's Exemption Permits**

60J. Any resident may apply to the Council for the issue to him of one or more permits for any vehicles belonging to and used by persons visiting that resident being vehicles of the types referred to in Article 60C.

60K. An application for a permit under Article 60J shall include such information and particulars as the Council may from time to time require and the Council shall be under no

obligation to consider any application which is not made in accordance with the provisions of this article.

60L. The Council may at any time require an applicant for a permit under Article 60C to produce to an officer of the Council such evidence in respect of their application as the Council may reasonably require in order to verify any information or particulars given to them by the applicant.

### **Issue of Visitor's Exemption Permits**

60M. Upon receipt of an application for a permit under Article 60J the Council upon being satisfied that the applicant is a resident shall issue a parking permit or permits (as the case may be) for the vehicles referred to in that application to the applicant.

60N. A permit issued under the provisions of Article 60H shall allow those vehicles in respect of which the permit was issued to proceed in the length of road specified in Schedule 35 to this Order as the Council shall at its discretion think fit for the needs of the applicant and his visitors.

60O. The Council may, at its absolute discretion, limit the number of visitors permits to be issued to any particular household at any one time and may require any used visitors permits to be produced and surrendered before any further permits are issued.

60P. A visitors permit shall be valid on any particular day or days (as the case may be) if and only if the date in question and the registration mark of the vehicle on which the permit is displayed are shown in such manner as may be required by the Council.

60Q. Where an application for a visitors permit is made under Article 60F that application shall be treated as an application under Article 60J save that:-

- (1) any visitors permit issued pursuant to an application under Article 60F shall only be valid for a maximum period of one month; and
- (2) only one such visitors permit may be issued to any one resident.

### **Prohibition of Driving, 9 pm and 5 am the following day, on a Friday, Saturday, Sunday and the day immediately prior to each Bank/Public Holiday**

60R. Save as provided in Article 60S of this Order, no person shall cause any vehicle to proceed along the lengths of road specified in **Schedule 36** of this Order, between 9 pm and 5 am the following day, on a Friday, Saturday and Sunday and the day immediately prior to each Bank/Public Holiday, each week.

### **Exemptions**

60S. Nothing in Article 60R of this Order shall apply to vehicles which are being used for Police, Fire or Ambulance purposes or anyone authorised by a Police Constable in uniform.

## **PART XV**

### **PROHIBITION OF CYCLING**

61. No person shall ride or cause to be ridden any pedal cycle or tricycle on any of the lengths of road specified in **Schedule 37** to this Order.

## **PART XVI**

### **6'6" WIDTH RESTRICTION**

62. Save as provided in Article 63 of this Order, no person shall cause any vehicle the width of which, inclusive of any load on the vehicle, exceeds 6 feet 6 inches to proceed in that length of road specified with **Schedule 38** to this Order.

### **Exemptions**

63. Nothing in Article 62 of this Order shall apply so as to prevent any person from causing any vehicle to proceed in the length of road specified in that Article if the vehicle is being used:-
- (a) for the conveyance of persons, good or merchandise to or from any premises situated on or adjacent to the length of road;
  - (b) for the purpose of agriculture in connection with land adjacent to the length of road or for the conveyance or haulage of timber felled upon that land;
  - (c) in connection with any building operation or demolition in or adjacent to the length of road, the removal of any obstruction to traffic in the length of road, the maintenance, improvement or reconstruction of the length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined Schedule 2 to the Telecommunications Act, 1984;
  - (d) in the service of a local authority in pursuance of its statutory powers or duties.

## **PART XVII**

### **ONE-WAY TRAFFIC RESTRICTIONS**

64. No person shall cause or permit any vehicle to proceed along the lengths of road or sides of road specified in **Schedule 39** to this Order, other than in the directions specified therein.

## **PART XVIII**

### **PROHIBITION OF RIGHT HAND TURN**

65. (1) No person shall cause or permit any vehicle proceeding along Abbey Road, Barrow-in-Furness, to make a right hand turn into Rawlinson Street unless that vehicle is a vehicle being used for police, fire brigade or ambulance purposes;
- (2) No person shall cause or permit any vehicle proceeding along Church Street, Barrow-in-Furness, to make a right hand turn into Greengate Street unless that vehicle is being used for police, fire brigade or ambulance purposes;
- (3) No person shall cause or permit any vehicle proceeding along Greengate Street (south-west), Barrow-in-Furness, to make a right hand turn into Rawlinson Street (south) unless that vehicle is being used for police, fire brigade or ambulance purposes;
- (4) No person shall cause or permit any vehicle proceeding along Burlington Street, Barrow-in-Furness, to make a right hand turn into Duke Street unless that vehicle is a vehicle being used for police, fire brigade or ambulance purposes.

## **PART XIX**

### **CYCLE LANE - AT ALL TIMES**

66. No person shall cause or permit any vehicle, other than a cycle, to proceed at any time along the lengths of road specified in **Schedule 39A** to this Order.

## **PART XX**

### **LENGTH RESTRICTION**

67. Save as provided in Article 70 of this Order, no person shall cause any vehicle the length of which, inclusive of any load on the vehicle, exceeds 30 feet, to proceed in St. Andrews Street, Barrow-in-Furness, between the hours of 10.00 pm and 6.00 am in any day.

### **Exemptions**

68. Nothing in Article 67 of this Order shall apply so as to prevent any person from causing any vehicle to proceed in the road specified in that Article if the vehicle is being used in connection with any building operation or demolition in or adjacent to the length of road, the removal of any obstruction to traffic in the length of road, the maintenance, improvement or reconstruction of the length of road, or the laying, erection, alteration or repair in or adjacent to that length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined Schedule 2 to the Telecommunications Act, 1984.



## **PART XXI**

### **PARKING PLACE FOR POLICE VEHICLES (AT ALL TIMES)**

69. No person shall cause or permit any vehicle, other than a vehicle being used for police purposes, to wait at any time in the length of road specified in **Schedule 40** to this Order.

## **PART XXII**

### **DALTON ROAD RESTRICTED ZONE**

70. Notwithstanding the foregoing provisions of this Order and for the avoidance of doubt, the lengths of road specified in columns 1, 2 and 3 of **Schedule 41** hereto, which also appear in the Schedules specified in column 4, lie within the Dalton Road Restricted Zone as indicated by traffic signs conforming to diagram 633 (varied to read "Restricted Zone") and diagram 664 of the 2016 Regulations and as such are not subject to the requirement that there be yellow or white lines (as applicable) to indicate the type of restriction, where these are usually required by the 2016 regulations.

## **PART XXIII**

### **MARITIME STREETS RESTRICTED ZONE**

- 70A. Notwithstanding the foregoing provisions of this Order and for the avoidance of doubt, the lengths of road specified in columns 1, 2 and 3 of **Schedule 42** hereto, which also appear in the Schedules specified in column 4, lie within the Maritime Streets Restricted Zone as indicated by traffic signs conforming to diagram 663.2 (varied to read "Restricted Zone") and diagram 664 of the 2016 Regulations and as such are not subject to the requirement that there be yellow or white lines (as applicable) to indicate the type of restriction, where these are usually required by the 2016 regulations.

## **PART XXIV**

### **APPLICATION FOR RESIDENTS PARKING PERMITS**

71. Any person, whose normal residence is listed in column 1 of **Schedule 43** to this Order and who is the owner or registered keeper of a vehicle, being either a passenger vehicle, goods vehicle, motor cycle with or without a sidecar attachment, not exceeding 2.28m in height and 5.50m in length, may apply to the Council for the issue of a resident's parking permit in respect of that vehicle for the Zone referred to in column 2 of Schedule 43.
72. Any application made in accordance with the foregoing Article shall include such particulars as the Council may from time to time require.

73. The Council may require an applicant for a permit to produce to an officer of the Council such evidence in support of their application as may be reasonably required by the Council to verify any particulars or information given to it by the applicant.
74. Any resident who is unable to provide the Council with such information as it may reasonably require in connection with his application may apply to the Council for the issue of a visitors permit under the provisions of Article 86.
75. Residents permits are not transferable nor do they have any effect outside the Zone specified on that permit.

### **Issue of Permits**

76. Upon receipt of an application for a parking permit made in accordance with Article 71 hereof the Council, upon being satisfied that the applicant is a resident and is either the owner or registered keeper of a vehicle referred to in his application, shall issue a parking permit for that vehicle to the applicant.
77. A parking permit issued under the provisions of Article 76 shall allow the vehicle in respect of which the permit is issued to park in any of those parking places listed in Schedule 43 to this Order as the Council shall, at its discretion, think fit for the applicant's needs.
78. Subject to the provisions of Articles 92 and 101, the Council shall not be obliged to issue a residents parking permit to an applicant for such a permit if two or more residents parking permits have previously been issued to any person or persons (as the case may be) residing at the same address as the applicant and at least two of those permits are valid at the time an application under Article 71 is made.

## **PART XXV**

### **APPLICATION FOR VISITOR'S PARKING PERMITS**

79. Any resident may apply to the Council for the issue to him of one or more parking permits for any vehicles belonging to and used by persons visiting that resident being vehicles of the types referred to in Article 71.
80. An application for a permit under Article 79 shall include such information and particulars as the Council may from time to time require and the Council shall be under no obligation to consider any application which is not made in accordance with the provisions of this article.
81. The Council may at any time require an applicant for a permit under Article 79 to produce to an officer of the Council such evidence in respect of their application as the Council may reasonably require in order to verify any information or particulars given to them by the applicant.

### **Issue of Permits**

82. Upon receipt of an application for a parking permit under Article 79 the Council upon being satisfied that the applicant is a resident shall issue a parking permit or permits (as the case may be) for the vehicles referred to in that application to the applicant.
83. A parking permit issued under the provisions of Article 82 shall allow those vehicles in respect of which the permit was issued to park in any of those parking places listed in Schedule 43 to this Order as the Council shall at its discretion think fit for the needs of the applicant and his visitors.
84. The Council may, at its absolute discretion, limit the number of visitors parking permits to be issued to any particular household at any one time and may require any used visitors parking permits to be produced and surrendered before any further permits are issued.
85. A visitors parking permit shall be valid on any particular day or days (as the case may be) if and only if the date in question and the registration mark of the vehicle on which the permit is displayed are shown in such manner as may be required by the Council.
86. Where an application for a visitors parking permit is made under Article 74 that application shall be treated as an application under Article 79 save that:-
  - (1) any visitors parking permit issued pursuant to an application under Article 74 shall only be valid for a maximum period of one month; and
  - (2) only one such visitors parking permit may be issued to any one resident.

## **PART XXVI**

### **APPLICATION FOR RESIDENTS ONLY PARKING PERMITS**

- 86A(i) A resident of Even Numbers 4 to 30 and Odd Numbers 1 to 23 Warwick Street, Barrow-in-Furness and No. 1 West View Road, Barrow-in-Furness, who is the owner or registered keeper of a vehicle, being:-
  - (i) a motor vehicle;
  - (ii) a motor vehicle constructed or adapted for use for the carriage of goods of any description the overall length of which does not exceed 5.00 metres and the overall height of which does not exceed 2.28 metres;
  - (iii) a motor cycle with or without a side-car; or
  - (iv) an invalid car,may apply to the Council for the issue of a resident parking permit in respect of that vehicle for the residents only parking place specified in Schedule 6A hereto .
- (ii) A resident of Even Numbers 144 to 156 Abbey Road, Even Numbers 2 to 38, Even Numbers 42 to 98, Even Numbers 132 to 202, Odd Numbers 145 to 199 inclusive of

Park Avenue, Barrow-in-Furness, and No. 79 Lorne Road, Barrow-in-Furness, who is the owner or registered keeper of a vehicle, being:-

- (i) a motor vehicle;
- (ii) a motor vehicle constructed or adapted for use for the carriage of goods of any description the overall length of which does not exceed 5.00 metres and the overall height of which does not exceed 2.28 metres;
- (iii) a motor cycle with or without a side-car; or
- (iv) an invalid car

may apply to the Council for the issue of a resident parking permit in respect of that vehicle for the residents only parking place specified in Schedule 6B hereto .

86B. Any application made in accordance with the foregoing provisions of this Article shall include such particulars as the Council may from time to time require.

86C. The Council may require an applicant for a permit to produce to an officer of the Council such evidence in support of their application as may be reasonably required by the Council to verify any particulars or information given to it by the applicant.

86D. Any resident who is unable to provide the Council with such information as it may reasonably require in connection with his application may apply to the Council for the issue of a visitors permit under the provisions of Article 86I.

86E. Residents permits are not transferable nor do they have any effect outside the street specified on that permit.

### **Issue of Permits**

86F. Upon receipt of an application for a parking permit made in accordance with Article 86A hereof the Council, upon being satisfied that the applicant is a resident and is either the owner or registered keeper of a vehicle referred to in his application, shall issue a parking permit for that vehicle to the applicant.

86G. A parking permit issued under the provisions of Article 86F shall allow the vehicle in respect of which the permit is issued to park in any of those parking places listed in Schedules 6A and 6B to this Order as the Council shall, at its discretion, think fit for the applicant's needs.

86H. Subject to the provisions of Articles 92 and 101, the Council shall not be obliged to issue a residents parking permit to an applicant for such a permit if two or more residents parking permits have previously been issued to any person or persons (as the case may be) residing at the same address as the applicant and at least two of those permits are valid at the time an application under Article 86A is made.

### **PART XXVII**

## **APPLICATION FOR VISITOR'S PARKING PERMITS**

- 86I. Any resident may apply to the Council for the issue to him of one or more parking permits for any vehicles belonging to and used by persons visiting that resident being vehicles of the types referred to in Article 86A.
- 86J. An application for a permit under Article 86I shall include such information and particulars as the Council may from time to time require and the Council shall be under no obligation to consider any application which is not made in accordance with the provisions of this article.
- 86K. The Council may at any time require an applicant for a permit under Article 86I to produce to an officer of the Council such evidence in respect of their application as the Council may reasonably require in order to verify any information or particulars given to them by the applicant.

### **Issue of Permits**

- 86L. Upon receipt of an application for a parking permit under Article 86I the Council upon being satisfied that the applicant is a resident shall issue a parking permit or permits (as the case may be) for the vehicles referred to in that application to the applicant.
- 86M. A parking permit issued under the provisions of Article 86L shall allow those vehicles in respect of which the permit was issued to park in any of those parking places listed in Schedules 6A and 6B to this Order as the Council shall at its discretion think fit for the needs of the applicant and his visitors.
- 86N. The Council may, at its absolute discretion, limit the number of visitors parking permits to be issued to any particular household at any one time and may require any used visitors parking permits to be produced and surrendered before any further permits are issued.
- 86O. A visitors parking permit shall be valid on any particular day or days (as the case may be) if and only if the date in question and the registration mark of the vehicle on which the permit is displayed are shown in such manner as may be required by the Council.
- 86P. Where an application for a visitors parking permit is made under Article 86I that application shall be treated as an application under Article 86A save that:-
- (1) any visitors parking permit issued pursuant to an application under Article 86I shall only be valid for a maximum period of one month; and
  - (2) only one such visitors parking permit may be issued to any one resident"

## **PART XXVIII**

### **APPLICATION FOR MARKET PARKING PERMITS**

87. Any market trader who is the owner or registered keeper of a vehicle being:-
- (1) a motor vehicle;
  - (2) a motor vehicle constructed or adapted for use for the carriage of goods of any description the overall length of which does not exceed 5.00 metres and the overall height of which does not exceed 2.28 metres;
  - (3) a motor cycle with or without side-car; or
  - (4) an invalid car,
- may apply to the Council for the issue of a market permit in respect of that vehicle.
88. Any application made in accordance with Article 87 above shall include such particulars as the Council may from time to time require.
89. The Council may require an applicant for a permit to produce to an officer of the Council such evidence in support of such application as may reasonably be required by the Council to verify any particulars or information given to it by the applicant.

### **Issue of Permits**

90. Upon receipt of an application for a permit made in accordance with Article 88 hereof the Council, upon being satisfied that the applicant is a market trader and is either the owner or registered keeper of a vehicle referred to in his application, shall issue a parking permit for that vehicle to the applicant.
91. A parking permit issued under the provisions of Article 90 shall allow the vehicle in respect of which the permit is given to gain access to the section of road listed in Schedule 34 to this Order.

## **PART XXIX**

### **APPLICATION FOR WAIVERS**

- 91A. Any contractor or tradesperson who is the owner or registered keeper of a vehicle may apply to the Council for the issue of a waiver in respect of that vehicle.

The Council will require the contractor or tradesperson to demonstrate that he is carrying out works in an area where parking restrictions apply and that the vehicle is essential to the undertaking of the works.

The application will be made on a form issued by the Council.

- 91B. Any application made in accordance with Article 91A above shall include such particulars as the Council may from time to time require.
- 91C. The Council may require an application for a waiver to produce to an officer of the Council such evidence in support of such application as may reasonably be required by the Council to verify any particulars or information given to it by the applicant.

#### **Issue of Waivers**

- 91D. Upon receipt of an application for a waiver made in accordance with Article 91B hereof the Council, upon being satisfied that the applicant is a contractor or tradesperson and is either the owner or registered keeper of a vehicle referred to in his application, shall issue a waiver for that vehicle to the applicant.
- 91E. A waiver issued under the provisions of Article 91D shall exempt the vehicle in respect of which the permit is given from the provisions of Part II, Articles 4 – 14) provided that the vehicle is parked so as not to cause obstruction or danger to other road users.

#### **Display of Waiver**

- 91F. At all times during which a vehicle is parked in a parking place for which a waiver has been issued by virtue of this Order, it shall be the duty of the driver to ensure that the waiver is displayed in the relevant position in accordance with the provisions of this Order and in the absence of such display it shall be assumed that a valid waiver has not been issued.

### **PART XXX**

#### **CONDITIONS ATTACHING TO PERMITS AND PARKING PLACES**

##### **Surrender of Permits**

92. A permit holder may surrender any permit which has been issued to him under the provisions of this Order at any time and shall immediately surrender any such permit upon the occurrence of any of the following events:-
- (1) the issue of a revised or duplicate permit by the Council under the provisions of Article 99;
  - (2) the expiry of the period (if applicable) for which the permit is valid;
  - (3) the withdrawal of a permit by the Council under the provisions of Article 94;  
or
  - (4) the revocation of the designation under this Order of the parking place to which that permit relates.

93. In the case either of a residents parking permit or a visitors parking permit when either:-
- (1) the permit holder has ceased to be a resident; or
  - (2) the vehicle in respect of which such a permit was issued is used or adapted so that it can no longer fall within any of those classes of vehicles as are listed in Article 73.

### **Withdrawal of Permits**

94. The Council may at any time require any permit holder to produce to an appropriate officer of the Council such evidence as that officer may reasonably require to enable him to verify the validity of any permit held by the permit holder and if such evidence is not forthcoming within 14 days from the date the Council requires the same, the Council may at its absolute discretion, withdraw the permit in accordance with the provisions of Article 95.
95. If it appears to the Council that any of the events set out in Article 94 have taken place or if any permit ceases to be valid pursuant to the provisions of that Article the Council may withdraw any permit it has issued by giving notice in writing of the withdrawal of that permit to the relevant permit holder at the address given by him on his application form or at any other address at which the Council has reason to believe that person is residing or by delivering it to him by hand at such address.

### **Amendment of Permits**

96. A permit holder may at any time apply to the Council for his permit to be amended so as to relate to a substitute vehicle or to the original vehicle and a substitute vehicle (as the case may be)
97. Any application made under the provisions of Article 96 must be accompanied by the permit which the applicant wishes to be amended and for the purposes of Article 98 any application shall not be treated as having been received by the Council until any such permit has also been received by them.
98. Upon receipt of an application made under Article 96, the Council may, at its discretion, either amend the permit as it sees fit or issue a revised permit to the applicant.

### **Duplicate Permits**

99. Should any permit become mutilated or accidentally defaced or should the figures or particulars thereon become illegible in any way the permit holder shall immediately surrender that permit to the Council and may apply to it for the issue to him of a duplicate permit.
100. If any permit is either lost or destroyed the permit holder may apply to the Council for a duplicate permit and the Council shall upon being satisfied as to the loss or destruction of the original permit issue the permit holder with a duplicate permit.

### **Permits to be in Writing**



101. All permits issued in accordance with the provisions of the Order shall be in writing and each permit shall include the following particulars:-
- (1) the registration mark or marks of the vehicle or vehicles (as the case may be) in respect of which it is issued;
  - (2) the period (if any) during which it remains valid; and
  - (3) Authentication that it has been issued by the Council.

### **Display of Permits**

102. At all times during which a vehicle is parked in a parking place for which a permit is required by virtue of this Order it shall be the duty of the driver to ensure that a valid permit is displayed in the relevant position in accordance with the provisions of this Order and in the absence of such display it shall be assumed that a valid permit has not been issued.

### **Removal of Permits**

103. Where a vehicle is displayed whether in or on a vehicle in accordance with Article 102 no person shall remove that permit from that vehicle unless they have been authorised to do so by the driver of that vehicle.

### **Indication of Parking Places and Signage**

104. It is hereby declared that (for the avoidance of doubt) that the Council shall (in its sole discretion) have the power to carry out the following actions, namely:-
- (i) to cause the limits of each and any parking place designated by this Order to be indicated on the carriageway by placing and maintaining thereon traffic signs of any size colour and type prescribed or authorised under Section 64 of the 1984 Act;
  - (ii) to place and maintain on or in the vicinity of each such parking place, traffic signs of any size colour and type prescribed or authorised under Section 64 of the 1984 Act indicating that such parking place may be used during the prescribed hours for the leaving of vehicles only as specified in this Order; and
  - (iii) to carry out such work as is reasonably required for the purposes of the satisfactory operation of these designated parking places.

### **Powers to Suspend Use of Parking Places**

105. Any Civil Enforcement Officer or other person duly authorised by the Council may suspend the use of any parking place or any part thereof whenever he or she considers such suspension reasonably necessary as follows:-
- (i) for the purpose of facilitating the movement of traffic or promoting its safety;

- (ii) for the erection maintenance or removal of any traffic sign adjacent to that parking place;
- (iii) for the purpose of any building operation, demolition or excavation in or adjacent to any parking place or the maintenance improvement or reconstruction of any such parking place or the laying erection alteration removal or repair in or adjacent to the designated parking place of any sewer or of any main pipe or apparatus for the supply of gas water or electricity or of any telegraphic line or traffic sign;
- (iv) for the cleansing of gullies in or adjacent to that parking place;
- (v) for the convenience of occupier of premises adjacent to any parking place on any occasion of the removal of furniture from one dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
- (vi) on any occasion of any public procession rejoicing or illumination, or where the streets are thronged or liable to be obstructed.

106. Without prejudice to the generality of any other statutory provision, a Police Constable in uniform may suspend for not longer than 24 hours the use of any parking place or any part thereof designated by this Part of this Order whenever he or she considers such suspension reasonably necessary for the purpose of facilitating the movement of traffic or promoting its safety.

### **Traffic Signs and Cones**

107. (1) Any person, Civil Enforcement Officer, Police Officer or other authorised person who causes the suspension of the use of any parking place or any part thereof in accordance with Articles 108 and 109 of this Order, shall thereupon place or cause to be placed in or adjacent to that designated parking place or the part thereof, the use of which is suspended, a traffic sign or cone indicating that waiting by motor vehicles is prohibited.
- (2) No person shall cause or permit a motor vehicle to be left in any part of a parking place so long as during such period there is in or adjacent to that designated parking place a traffic sign or cone placed in pursuance the preceding Articles of this Order.

### **Powers to remove vehicles in Parking Places**

108. (1) It is hereby declared for the avoidance of doubt and in pursuance of statutory powers in that behalf, if any vehicle is left in a position other than in accordance with the forgoing provisions of this Order, then a Police Constable, Civil Enforcement Officer or other person authorised by the Council in that behalf:-
- (i) may alter or cause to be altered, the position of the vehicle so that its position is in accordance with the said provisions; or

(ii) may alter or cause to be altered, the position of the vehicle or remove or arrange for the removal of the vehicle to a secure place in the manner and on the basis set out in this Article.

(2) Any person or persons altering, or causing the alteration of, the position of any vehicle by virtue of paragraph (1) (i) or (1)(ii) of this Article, may do so by towing or driving the vehicle or in such other manner as he or she or they may think reasonably necessary to enable the position of the vehicle to be altered or the vehicle to be removed.

(3) Any person or persons removing or arranging for the removal of any vehicle by virtue of paragraph (1) (i) or (1)(ii) of this Article shall make such arrangements as he/she or others considers to be reasonably necessary for the safety of the vehicle in the place to which it is removed.

109. No person shall, except with the permission of a Police Constable, Civil Enforcement Officer or other person duly authorised by the Council in that behalf, drive or permit to be driven any vehicle in a parking place for any purpose other than the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order or for the purposes of departing from the parking place.

## **PART XXXI**

### **REVOCAION OF EXISTING ORDERS**

110. The Orders specified in **Schedule 44** to this Order are hereby revoked in their entirety unless otherwise specified therein, and to the extent that the provisions of this Order are inconsistent with, or incompatible with, the provisions of any other Order, Byelaws or enactment relating to traffic regulation in the Barrow-in-Furness area not specifically referred to in the said Schedule, the provisions of this Order shall prevail for all purposes.
