

**THE COUNTY OF CUMBRIA (VARIOUS ROADS, BARROW-IN-FURNESS)  
(CONSOLIDATION OF TRAFFIC REGULATIONS) ORDER 2023**

1. The Cumbria County Council hereby give notice that on 14 March 2023 it made the above Order under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.
2. The Order will come into operation on 20 March 2023 and its effect will be to revoke, re-enact and consolidate the restrictions and provisions of the following Orders into one concise Order (“the Consolidation Order”) without any change of substance: -

for a period of 6 weeks commencing on 17 March 2023.
4. If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act or any instrument made there under has not been complied with in relation to the Order, you may within six weeks of 14 March 2023 apply to the High Court for this purpose.
