THE COUNTY OF CUMBRIA (C2007 GREAT BROUGHTON, C2016 SEATON, AND A591 AND A595 BOTHEL) (SPEED LIMITS) ORDER 2021

The County Council of Cumbria in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. This Order shall come into operation on 8 February 2021 and may be cited as The County of Cumbria (C2007 Great Broughton, C2016 Seaton, and A591 and A595 Bothel) (Speed Limits) Order 2021
- 2. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour along the lengths of road specified in Schedule 1 hereto.
- 3. No person shall cause or permit any vehicle to proceed at a speed exceeding 50 miles per hour along the lengths of road specified in Schedule 2 hereto
- 4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
- 5. In accordance with Section 87 of the Act, no speed limit imposed by this Order shall apply to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that speed limit would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion.
- 6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Lengths of road subject to 30 mph Speed Limit

From a point 650m north-west of its junction with the C2016 (grid ref: 307022 - 531746) to a point 765m north-west of that junction (grid ref: 306924 - 531809).

Seaton

C2016 Lowca Lane From a point 35m north-west of its junction with Hazel Grove (grid ref: 301058 – 531065) to a point 120m north-west of that junction (grid ref: 300985 - 531112).

A595	From a point approximately 250m south-west of its junction with the A591 (grid ref: 317867 – 538477) to a point approximately 250m northeast of its junction with the C2001 (grid ref: 318376 – 539499); a total distance of approximately 1.25km.
A591	From a point at its junction with the A595 to a point approximately 300m south-east of its junction with the A595 (grid ref: 318234 – 538340).
