

CUMBERLAND COUNCIL (VARIOUS FOOTPATHS IN THE CUMBERLAND AREA)  
(TEMPORARY PROHIBITION OF PEDESTRIANS) ORDER 2023 AND  
CUMBERLAND COUNCIL (CALDEW CYCLEWAY)(TEMPORARY PROHIBITION OF  
PEDESTRIANS AND CYCLISTS) ORDER 2023 AND  
CUMBERLAND COUNCIL (BRIDLEWAY NO.111002 IN THE PARISH OF  
CUMMERSDALE) (TEMPORARY PROHIBITION OF PEDESTRIANS, HORSES AND  
CYCLISTS) ORDER 2023

NOTICE IS HEREBY GIVEN that the Orders made by Cumberland Council on 13 June 2023, which became operative on 19 June 2023, to enable Galliford Try Construction to carry out works in connection with the construction of the Carlisle Southern Link Road (“the Works”) and which would otherwise expire on 19 December 2023

**:have been continued in force with the approval of the Secretary of State for Transport until 31 March 2025.**

The effect of which is to;

1. Prohibit pedestrians from proceeding along the following sections of Public Footpath:

- (a) An approx. 268 metre section of Footpath No. 111004 in the Parish of Cummersdale between Grid References: 339463 552627 and 339257 552502.
- (b) An approx. 431 metre section of Footpath No. 111005 in the Parish of Cummersdale between Grid References: 338733 552810 and 338686 552395.
- (c) An approx. 574 metre section of Footpath No. 111006 in the Parish of Cummersdale between Grid References: 339441 552506 and 339051 552150.
- (d) An approx. 253 metre section of Footpath No. 111008 in the Parish of Cummersdale between Grid References: 336915 553592 and 337040 553397.
- (e) An approx. 663 metre section of Footpath No. 129001 in the Parish of St Cuthbert Without between Grid References: 339513 552257 and 339057 551815.
- (f) An approx. 421 metre section of Footpath No. 129003 in the Parish of St Cuthbert Without between Grid References: 339936 551279 and 340197 550947.
- (g) An approx. 418 metre section of Footpath No. 129004 in the Parish of St Cuthbert Without between Grid References: 339773 551422 and 339449 551214.
- (h) An approx. 687 metre section of Footpath No. 129005 in the Parish of St Cuthbert Without between Grid References: 339197 551885 and 339121 551239
- (i) An approx. 565 metre section of Footpath No. 129017 in the Parish of St Cuthbert Without between Grid References: 343396 551826 and 343489 551302
- (j) An approx. 324 metre section of Footpath No. 129024 in the Parish of St Cuthbert Without between Grid References: 339771 550959 and 339471 551069.
- (k) An approx. 147 metre section of Footpath No. 129032 in the Parish of St Cuthbert Without between Grid References: 343529 551322 and 343597, 551196.
- (l) An approx. 224 metre section of Footpath No. 114018 in the Parish of Dalston between Grid References: 339051 552150 and 338861 551997.
- (m) An approx. 91 metre section of Footpath No. 114053 in the Parish of Dalston between Grid References: 338686 552395 and 338642 552317.

There are no suitable alternative routes available for pedestrians during the restrictions detailed in 1(a) to 1(m) above inclusive.

2. Prohibit pedestrians and cyclists from proceeding along the following sections of the Caldew Cycleway:

(a) An approx. 168 metre section between Grid References: 339001 552104 and 339125 552204; and

(b) An approx. 68 metre section between Grid Reference: 339468 552566 to 339441 552506.

There is no suitable alternative route available for pedestrians and cyclists during the restrictions detailed in 2(a) and 2(b) above inclusive. However, the contractor on site will provide a suitable alternative route at times when works allow and is deemed safe to do so. This would be signed on the ground.

3. Prohibit pedestrians, horses and cyclists from proceeding along an approx. 609 metre section of Bridleway No. 111002 in the Parish of Cummersdale, between Grid References: 338136 553129 and 338585 553110.

There is no suitable alternative route available for pedestrians, horses or cyclists during the restriction detailed in 3 above.
