

CUMBERLAND COUNCIL (VARIOUS FOOTPATHS IN THE CUMBERLAND AREA)
(TEMPORARY PROHIBITION OF PEDESTRIANS) ORDER 2023, AND
CUMBERLAND COUNCIL (BRIDLEWAY NO.138048 IN THE PARISH OF WETHERAL)
(TEMPORARY PROHIBITION OF PEDESTRIANS, HORSES AND CYCLISTS)
ORDER 2023

NOTICE IS HEREBY GIVEN that the Orders made by Cumberland Council on 9 May 2023, which became operative on 15 May 2023, to enable Cumberland Council to carry out works in respect of bridge repairs and bridge replacement works (“the Works”) and which would otherwise expire on 15 May 2024

:have been continued in force with the approval of the Secretary of State for Transport until 15 November 2024.

The effect of the Orders is to

1. Prohibit pedestrians from proceeding along the following sections of Public Footpath:

- (i) An approx. 190 metre section of Footpath No. 138045 at Cumwhitton in the Parish of Wetheral between Grid References: 349787 552747 and 349613 552808; and
- (ii) An approx. 8 metre section of Footpath No. 254010 in the Parish of Thursby between Grid References: 331587 549505 and 331591 549512; and
- (iii) An approx. 8 metre section of Footpath No. 106001 in the Parish of Burgh by Sands between Grid References: 333343 559123 and 333350 559125; and
- (iv) An approx. 8 metre section of Footpath No. 107016 at Lanercost in the Parish of Burtholme between Grid References: 354828 564419 and 354835 564420; and
- (v) An approx. 18 metre section of Footpath No. 119007 at Newtown in the Parish of Irthington between Grid References: 350554 563480 and 350558 563496.

There are no suitable alternative routes available for pedestrians during the restrictions detailed in 1 (i) to 1(v) above, inclusive.

2. Prohibit pedestrians, horses and cyclists from proceeding along an approx. 6 metre section of Bridleway No. 138048 at Lonsdale Park in the Parish of Wetheral, between Grid References: 346393 551903 and 346397 551908.

There is no suitable alternative route available for pedestrians, horses or cyclists during the restriction detailed in 2 above.
