

ECO4 Flex: Registered Installers

Cumberland Council currently has **19** installers registered to provide energy efficiency measures under the Ofgem ECO4 Flex scheme in the Cumberland area.

The list of registered installers is attached overleaf, shown in alphabetical order.

For ECO4 Flex:

If your household meets the flexible eligibility criteria, you should apply via a registered installer, as the installer will need to send your application to the Council so that we can issue an eligibility declaration to them and to Ofgem.

For ECO4 (and GBIS):

If your household meets the standard eligibility criteria, your application will not be sent to the Council for verification. You can use this list to find an installer who is operating in the area, but other installers may be operating independently.

Registered installers have all completed an onboarding process and we have verified that each company holds the correct accreditations and insurances for the improvement measures that they offer. We cannot recommend a particular installer or endorse the quality of their workmanship. You should conduct your own research into these companies before making enquiries.

Energy suppliers work with third-party installers to deliver the scheme and it is up to the energy suppliers to determine which measures they choose to fund, the level of funding they provide and the installers they choose to work with. Registered installers each have different funding agreements in place, directly with energy suppliers and/or with ECO managing agents. The types of measures installers are able to install may also differ.

This means that different installers may offer different amounts of funding and different types of improvements for your home. We therefore recommend enquiring with more than one installer to consider the options available.
