**NOTICE OF DETERMINATION**

**Application Number: CA10/42**

Notice is hereby given that Cumbria County Council, as the Commons Registration Authority ("the CRA"), has considered an application submitted by Tim Cartmell ("the Applicant") to correct a mistake made by the CRA relating to the particulars of the dominant tenement in column 5 of entry No. 62 of the Commons Register Unit CL20 Caldbeck Common as described in the attached notice of application.

**Decision**

The CRA resolved to accept the application to correct the Register by amending column 5 of Register Unit CL20 Caldbeck Common.


**Reasons**

**Commons Act 2006 - Section 19(2)(a)  
NOTICE OF APPLICATION TO CORRECT THE REGISTER**

Notice is hereby given that an application has been made by Tim Cartmell (“the Applicant”) to Cumbria County Council as Commons Registration Authority, under Section 19(2)(a) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL20, Caldbeck Common.

A summary of the effect of the application is as follows: A right of common at entry number 62 of register unit CL20 was registered as a result of application number 1036 dated 24<sup>th</sup> June 1968 (“the 1968 Application”). The Applicant claims that a mistake was made by the commons registration authority in recording the particulars of the dominant tenement in column 5. The right was recorded as attached to a number of fields including the whole of the OS field numbered 623 and not part 623 as stated at Part 6 of the 1968 Application.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by deleting entry number 62 (making reference to the new corresponding entry) and creating a new entry, recording the right as attached (among others) to part 623, in accordance with the 1968 Application.


- must quote the Application No. **CA10/42**
- must state the name and postal address of the person making them, and the nature of that person’s interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations will not be treated as confidential, to determine the application it will be necessary for the Commons Registration Authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The date on which the period for making representations expires is **5pm on 1<sup>st</sup> August 2019**.
