Commons Act 2006 - Section 19(2)(b) NOTICE OF APPLICATION TO CORRECT THE REGISTER

Notice is hereby given that an application has been made by **Askham Bryan College** ("the Applicant") to Cumbria County Council as Commons Registration Authority, under Section 19(2)(b) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to register unit CL293 Mungrisdale Common.

A summary of the effect of the application is as follows: A right to graze 500 ewes and 160 ewe hoggs on Mungrisdale Common comprising the whole of the land in this register unit was registered at entry 17 of register unit CL293 pursuant to application made on 8th April 1968 and numbered 343 ('the 1968 Application'). The 1968 Application listed the fields to which the rights were attached as O.S. nos. 57, 58, 56, 95, 96, 97, 98, 99, 100, 125, 102, 103, 94, 131, 132, 133, 130, 129, 128, 134, 126, 127, 136, 202, 205, 142, 143, 145, 150, 151, 152, 153, 154, 155, 156, 157, 158, 159, 160, 161, 162, 163, 164, 165, 166, 189, 190, 245, 244, 246, 247, 241, 243, 694, 693, 690, 695pt, 677 and 676. The Applicant claims that O.S. fields nos. 245, 244, 246, 247, 241, 243, 694, 693, 690, 695pt, 677 and 676 ('the Greenah Crag Land') were not part of the dominant tenement and were included in that list erroneously. The Applicant claims that the Greenah Crag Land originated from allotments from the enclosure of Hutton Soil and Berrier Common, had no rights attached to it and was in a different manor to Mungrisdale Fell and Bowscale Fell. The Applicant requests that this error is corrected and the Greenah Crag Land is removed from the dominant tenement.

Entry 17 was cancelled in 2018 and replaced by entries which registered partial declaration (entry 47), apportionment (entry 48), severance of part of the right (entry 51) and the remainder (entry 50). If the application is granted the Commons Registration Authority will give effect to the determination by deleting current entries 47, 48, 50 and 51 (making reference to the new corresponding entries) and making new entries in the register which will have apportionments recalculated on the basis of the amended dominant tenement as shown in the table attached to this notice. New supplemental maps will be prepared where necessary.

Any person wishing to make representations:

- must quote the Application No. CA10/53
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential. Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.
