

## Commons Act 2006 - Schedule 2 (2) Application to register land as common land

Notice is hereby given that an application has been made by **the Open Spaces Society** ("the Applicant") to Cumbria County Council as Commons Registration Authority, under Schedule 2 paragraph 2 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to several parcels of land at Goose Holme, Kendal shown coloured blue on the attached plan ("the Application Land").

A summary of the effect of the application is as follows: The Applicant claims that the Application Land was not at any time finally registered as common land or as a town or village green under the Commons Registration Act 1965 and that it is recognised by or under a statute as common land and thus satisfies the criteria specified in paragraph 2 of Schedule 2 of the Commons Act 2006. The Applicant claims that the Application Land was erroneously omitted from registration as register unit CL153 Goose Holme and has requested that the Application Land is added to the commons register unit CL153.

If the application is granted, in whole or in part, the commons registration authority will give effect to the determination by registering the Application Land as common land, which will entail the addition of a registration amendment entry in register unit CL153 confirming the addition of new land to be comprised in the same register unit, and the amendment or preparation of a fresh edition of the register map showing the Application Land contained within the boundary of register unit CL153.

Any person wishing to make representations:


- must quote the Application No. **CA13/27**;
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and
- must be sent to: The Commons Registration Service, Lady Gillford's House, Petteiril Bank Road, Carlisle, Cumbria, CA1 3AJ or email: [commons.registration@cumbria.gov.uk](mailto:commons.registration@cumbria.gov.uk)

Any representations made will not be treated as confidential. To determine the application it will be necessary for the Commons Registration Authority to disclose information received to others, which will include the applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The date on which the period for making representations expires is 5pm on 27<sup>th</sup> August 2019.

Documents relating to the application are not available online; these are only available for inspection at the Commons Registration Service at the above address, strictly by appointment only. Please contact the Commons Registration Team on (01228) 221028 to arrange an appointment.

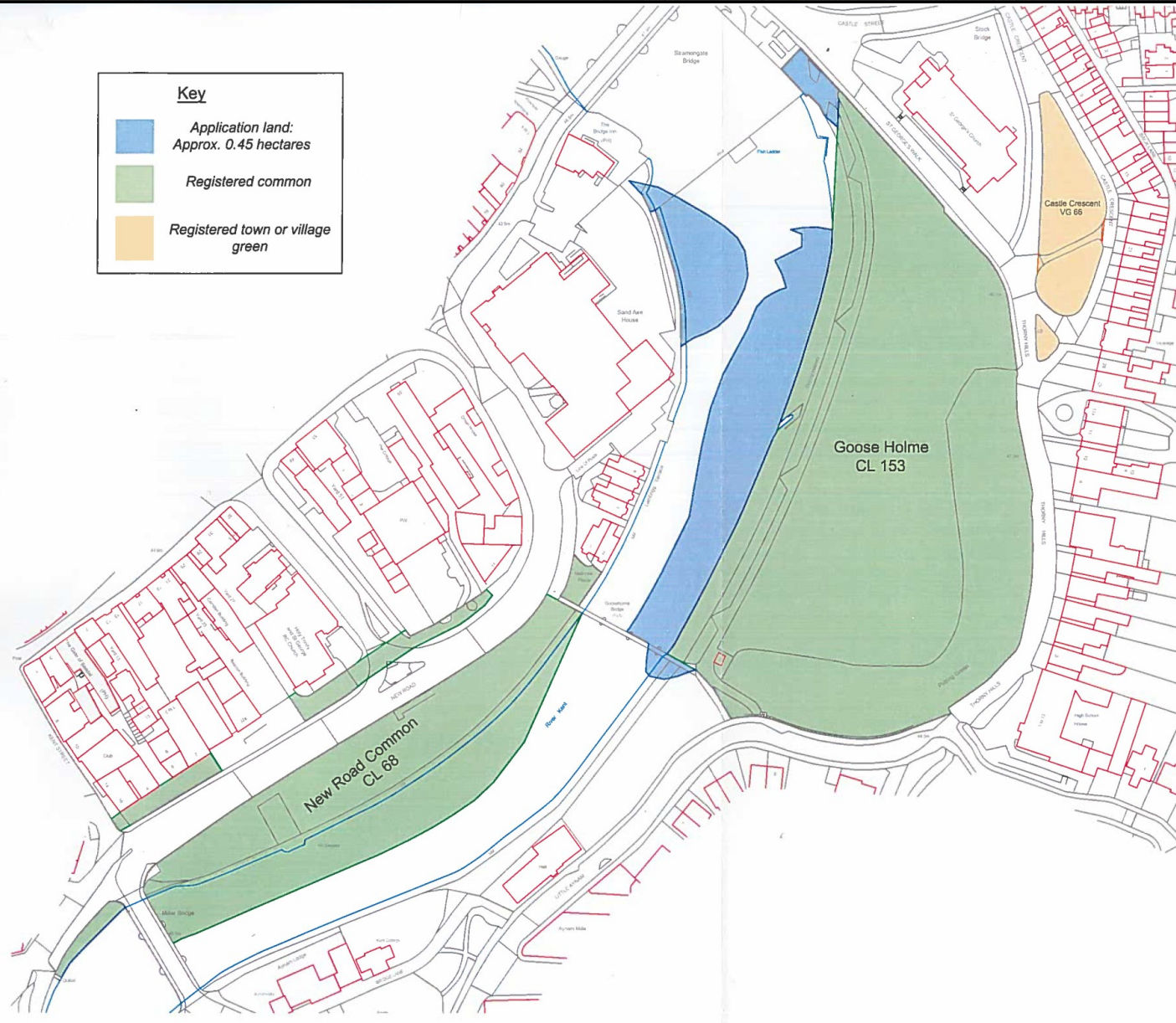
