## Application to amend the register to record an historic event

Notice is hereby given that an application has been made by **Malcolm Morland Hutchinson**, **Jean Hutchinson** and **Richard Ian Hutchinson** ("the Applicants") to Cumbria County Council as Commons Registration Authority, concerning rights of common on CL21 Winton and Kaber Regulated Common described more fully below.

A summary of the effect of the application is as follows: The rights to graze 339.5 sheep or such other commonable animals equivalent to 339.5 stints, together with the right of turbary, estovers and the right to take sand and gravel over the whole of the land comprised in this register unit ("the Right") is currently registered as held in gross at Entries 50 (41 stints), 61 (73.5 stints), 69 (9.5 stints), 81 (3.5 stints), 90 (5 stints), 92 (37 stints), 94 (133 stints) and 117 (37 stints) of register unit CL21. By a transfer dated 16 September 2010 all of the Rights were transferred to the Applicants. The Applicants seek by this application to register the Rights in their own names.

If the application is granted, the registration authority will give effect to the determination by deleting the current entries and creating new entries to show the Applicants as the owners of the Rights.

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicants and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at **5pm** on **9 February 2018.**
