

## Commons Act 2006 – Schedule 3

### NOTICE OF APPLICATION TO AMEND THE REGISTER TO RECORD AN HISTORIC EVENT

Notice is hereby given that an application has been made by **John Keith Benn** (“the Applicant”) to Cumbria County Council as Commons Registration Authority, under Schedule 3 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL60 Carrock Fell and Mungrisedale Fell.

A summary of the effect of the application is as follows: the right to graze 46 units on Bowscale Fell comprising the whole of the land in this register unit (“the Right”) is currently registered as attached to O.S. fields numbered 70, 71, 60, 24 and 42 at entry 28 of register unit CL60 in the name of John Keith Benn. The Applicant claims that the proportion of the Right attached to O.S. fields numbered 70 and 71 was severed from the land upon the sale of those fields to Kenneth David Hebson on 29<sup>th</sup> September 2000. The Applicant seeks to show by this application that the portion of the Right to be severed equates to 15 units.

This secondary application can only be considered if the primary application (CA14/26) is granted. If granted, the Commons Registration Authority will give effect to the determination by deleting entry 28 of register unit CL60 and by making two new entries in the register to show the proportion of the Right currently attached to O.S. fields 70 and 71 as severed from the land and held in gross and the rest of the Right as attached to the remainder of the dominant tenement.

Any person wishing to make representations:


- must quote the Application No. **CA14/27**
- must state the name and postal address of the person making them, and the nature of that person’s interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at **5pm on 20<sup>th</sup> July 2018**.
