

## Commons Act 2006 – Schedule 3 NOTICE OF APPLICATION TO AMEND THE REGISTER TO RECORD AN HISTORIC EVENT Primary Application - Severance

Notice is hereby given that an application has been made by **Mary Wood** ("the Applicant") to Cumbria County Council as Commons Registration Authority, under Schedule 3 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register CL10 Crosby Ravensworth Fell.

A summary of the effect of the application is as follows: The right to graze 200 ewes with followers over the whole of the land comprised in this register unit ("the Right") is registered as attached to O.S. fields numbered 493, 811, 817, 912, 916, 919, 922, 923, 924, 928, 929, 931, 932, 933, 935, 962 and 963 at entry 5 of register unit CL10. A declaration of partial entitlement was made on 17<sup>th</sup> March 2016 and part of the Right relating to 197 ewes is now registered under the name of the Applicant at entry 88 of register unit CL10. The remaining rights are still registered at entry 5 as attached to the southern portion of O.S. 919. The southern portion of O.S. field number 919 was swapped by a deed of exchange dated 19<sup>th</sup> January 1979 and, although the deed is silent on the matter, the Applicant claims that the proportion of the Right attached to the southern portion of O.S. field number 919 was severed from the land and retained by the existing owner of the right at the time by mutual agreement with the buyer. The Applicant seeks by this application to register that severance in the register.

If this application is granted, the rights attached to the southern portion of O.S. field number 919 will be considered to be severed from the land and held in gross.

Any person wishing to make representations:

- must quote the Application No. CA14/28
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 8<sup>th</sup> January 2018.
