

## Commons Act 2006 – Schedule 3 NOTICE OF APPLICATION TO AMEND THE REGISTER TO RECORD AN HISTORIC EVENT Secondary Application - Apportionment

Notice is hereby given that an application has been made by **Dennis Henry Strong** ("the Applicant") to Cumbria County Council as Commons Registration Authority, under Schedule 3 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register CL20 Caldbeck Common..

A summary of the effect of the application is as follows: The right to graze 114 ewes and followers and 30 hoggs on Caldbeck Common comprising the whole of the land in this register unit ("the Right") was registered as attached to Lonning Foot Farm O.S. Nos. 175, 153, 148, 152, 151, 150 and 112 at entry 109 of register unit CL20.

As a result of a transfer dated 2<sup>nd</sup> February 2001 the Right was transferred to the Applicant with the majority of the dominant tenement. The Applicant sold a portion of the Right via a transfer dated 18<sup>th</sup> April 2001 along with a portion of the dominant tenement, and in October 2001 applied to register the remaining part of the Right equating to 50 ewes and followers and 13 hoggs, which are currently shown as attached to land at entry 215 under the name of the Applicant.

The Applicant seeks by this application to show that of the 50 ewes and followers and 13 hoggs recorded at entry 215 the rights for 22.33 ewes and followers and 5.72 hoggs should be severed and shown held in gross, leaving 27.67 ewes and followers and 7.28 hoggs attached to land on a proportional basis.

This secondary application can only be considered if the primary application (CA14/40) is granted. If granted the Commons Registration will give effect to the determination by cancelling entry 216 and creating two new entries to show a proportion of the Right being held in gross and the remainder being attached to land, both under the name of the Applicant.

Any person wishing to make representations:

- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must state the grounds on which they are made and must be signed by the person making them;

Any representations made will not be treated as confidential, to determine the application it will be necessary for the authority to disclose information received from you to others, which will include the Applicants and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at **5pm** on **10<sup>th</sup> September 2018**.
