

**Commons Act 2006 – Schedule 3**  
**NOTICE OF APPLICATION TO AMEND THE REGISTER TO RECORD AN HISTORIC EVENT**  
**Primary Application - Severance**

Notice is hereby given that an application has been made by **Askham Bryan College** (“the Applicant”) to Cumbria County Council as Commons Registration Authority, under Schedule 3 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register CL293 Mungrisdale Common.

A summary of the effect of the application is as follows: The right to graze 500 ewes and 160 ewe hogs on Mungrisdale Common, comprising the whole of the land in this register unit (“the Right”) is registered as attached to O.S. plots numbered 57, 58, 56, 95, 96, 97, 98, 99, 100, 125, 102, 103, 94, 131, 132, 133, 130, 129, 128, 134, 126, 127, 136, 202, 205, 142, 143, 145, 150, 151, 152, 153, 154, 155, 156, 157, 158, 159, 160, 161, 162, 163, 164, 165, 166, 189, 190, 245, 244, 246, 247, 241, 243, 694, 693, 695pt, 690, 677 and 676 at entry 17 of register unit CL293.

As a result of a conveyance dated 5<sup>th</sup> March 1996, land at Redmire Farm comprising of O.S. fields 133, 130 and 131 was sold. The Applicant believes that the associated rights were not included in this conveyance, and the Applicant states that they have claimed Basic Payment Scheme on those rights, and believed and acted as though the rights were still held by them. The Applicant seeks by this application to register the severance in the register.

If this application is granted, the rights attached to O.S. field numbers 133, 130 and 131 will be considered to be severed from the land and held in gross.

Any person wishing to make representations:


- must quote the Application No. **CA14/53**
- must state the name and postal address of the person making them, and the nature of that person’s interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at **5pm on 25<sup>th</sup> July 2018**.
