Commons Act 2006 – Schedule 3 NOTICE OF APPLICATION TO AMEND THE REGISTER TO RECORD AN HISTORIC EVENT Secondary Application - Apportionment

Notice is hereby given that an application has been made by **Dennis Henry Strong** ("the Applicant") to Cumbria County Council as Commons Registration Authority, under Schedule 3 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register CL20 Caldbeck Common.

A summary of the effect of the application is as follows: The right to graze 100 ewes, 50 hoggs, and 100 lambs on West Fell, comprising part of the land in this register unit ("the Right") was registered as attached to land at Scalerigg House at entry 92 of register unit CL20. As a result of an assignment dated 9th February 2001 ("the Assignment") part of the Right equating to 40 ewes, 20 hoggs and 40 lambs was transferred to the Applicant along with 9.405 acres of the original 48.116 acre dominant tenement. Following an application made in October 2001 these rights were recorded as attached to land at entry 216 under the name of the Applicant

The Applicant seeks by this application to show that of the 40 ewes, 20 hoggs and 40 lambs transferred with the Assignment a proportion were attached to the land transferred, leaving the remainder severed and held in gross. On a proportional basis this would result in the rights for 20.45 ewes, 10.23 hoggs and 20.45 lambs being severed, leaving 19.55 ewes, 9.77 hoggs and 19.55 lambs attached to land.

This secondary application can only be considered if the primary application (CA14/60) is granted. If granted the Commons Registration will give effect to the determination by cancelling entry 216 and creating two new entries to show a proportion of the Right being held in gross and the remainder being attached to land, both under the name of the Applicant.
