Commons Act 2006 - Section 12 NOTICE OF APPLICATION TO TRANSFER A RIGHT OF COMMON IN GROSS

Notice is hereby given that an application has been made by **David Jackson and Angela Mary Jackson** ("the Applicants") to Cumbria County Council as Commons Registration Authority, under Section 12 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL39 Ravenstonedale Common.

A summary of the effect of the application is as follows: The right to graze 41.23 sheep with their lambs, or cattle and sheep together on the basis of 1 beast equivalent to 10 sheep over the whole of the land comprised in this register unit ("the Right") is currently registered as held in gross (not attached to land) at entry 136 of register unit CL39 in the names of John Richard Metcalfe and Dorothy Brenda Metcalfe. The Applicants claim that part of the Right, amounting to 25.05 sheep, was transferred to them by way of a Deed dated 2nd November 2017. The Deed does not operate at law until registered by the Commons Registration Authority in the register. The Applicants seek by this application to complete the transfer of ownership and register part of the Right in their names.

If the application is granted, in whole or in part, the Commons Registration Authority will give effect to the determination by making a new entry in the register to show the Applicants as the owners of part of the Right equating to 25.05 sheep, leaving the remaining 16.18 sheep grazing rights as shown as held in gross under the names of the current owners.

Any person wishing to make representations:

Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 5 February 2019.
