

**Commons Act 2006 - Section 12**  
**NOTICE OF APPLICATION TO TRANSFER A RIGHT OF COMMON IN GROSS**

Notice is hereby given that an application has been made by **Robert Cowperthwaite, Samuel Clifford Cowperthwaite and Lindsey Cowperthwaite** ("the Applicants") to Cumbria County Council as Commons Registration Authority, under Section 12 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register units CL93 North and East Mallerstang, and CL94 Western Mallerstang Common, south of Friths.

A summary of the effect of the application is as follows:

The right to graze (a) 229.36 ewes with their unweaned lambs and 76.45 hogs or 30.58 cattle or sheep and cattle together on the basis of 1 beast to 10 sheep and (c) 9.17 pigs over the whole of the land comprised in this register unit together with the whole of the land comprised in register unit CL94 ("the Right") is currently registered as held in gross (not attached to land) at entry 96 of register unit CL93 and at entry 71 of register unit CL94 in the names of William Anthony Shaw Kilvington and Sandra Atkinson.

The Applicants claim that the right was transferred to them by way of a deed dated 10 January 2020. The transfer does not operate at law until registered by the Commons Registration Authority in the register. The Applicants seek by this application to complete the transfer of ownership and register the Right in their names.

If the application is granted, in whole or in part, the Commons Registration Authority will give effect to the determination by making new entries in the registers showing the applicants as the owners of the Right.

Any person wishing to make representations:

- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 16 March 2020.
