NOTICE OF APPLICATION TO TRANSFER A RIGHT OF COMMON IN GROSS

Notice is hereby given that an application has been made by **Martin James Pinfold and Katharine Beatrice Pinfold** ("the Applicants") to Cumbria County Council as Commons Registration Authority, under Section 12 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL67 Matterdale Common.

A summary of the effect of the application is as follows:

The right to graze 26 stints (one stint being equal to six barren ewes or four ewes with lambs or one head of cattle, or one horse equalling two stints) on Matterdale Common comprising the whole of the land in this register unit ("the Right") is currently registered as held in gross (not attached to land) at entry 94 of register unit CL67 in the names of John William Young, Susan Mary Wearing, Kathleen Miller and Carol Elizabeth Muir.

The Applicants claim that the right was transferred to them by way of a deed dated 29th January 2021. The transfer does not operate at law until registered by the Commons Registration Authority in the register. The Applicants seek by this application to complete the transfer of ownership and register the Right in their names.

If the application is granted, in whole or in part, the Commons Registration Authority will give effect to the determination by making a new entry in the register showing Martin James Pinfold and Katharine Beatrice Pinfold as the owners of the Right.

Any person wishing to make representations:

- must quote the Application No. **CA6/131**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 4 June 2021.

Documents relating to the application are not available online although they can be provided on request. Requests should be sent directly to the Commons Registration Service using the contact details above.
