

Commons Act 2006 - Section 12 NOTICE OF APPLICATION TO TRANSFER A RIGHT OF COMMON IN GROSS

Notice is hereby given that an application has been made by **Keith Watt Lawson as Executor of Thomas Armstrong Watson** ("the Applicant") to Cumbria County Council as Commons Registration Authority, under Section 12 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL475 Scad Beck Common and CL2 Foreshore.

A summary of the effect of the application is as follows: The right to graze (b) 22 ½ stints or such number of stints as were formerly vested in Metropolitan Railway Country Estates Ltd. Each stint for 2 stirks or 1 heifer and followers or 4 sheep and followers, comprising the whole of the land in this register unit CL475 Scad Beck Common together with the land north west of AB in register unit CL2 Foreshore ("the Right") is currently registered as held in gross (not attached to land) at entry 1 of register unit CL475 and entry 3 of CL2 in the name of Mr Thomas Armstrong Lawson. The Applicant claims that the Right was transferred to him by way of an Assent dated 28th September 2001. The transfer does not operate at law until registered by the Commons Registration Authority in the registers. The Applicant seeks by this application to complete the transfer of ownership and register the Right in his name and the name of Renee Lawson.

If the application is granted, in whole or in part, the Commons Registration Authority will give effect to the determination by deleting current entries 1 of CL475 and 3 of CL2 (making reference to the new corresponding entries) and making new entries in the registers to show Keith Watt Lawson and Renee Lawson as the owners of the Right.

Any person wishing to make representations:

- must quote the Application No. CA6/98
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 18 January 2019.
