

Commons Act 2006 - Section 15(2) NOTICE OF APPLICATION TO REGISTER A NEW TOWN OR VILLAGE GREEN

Please note that this is a new application submitted in addition to application CA9/4 received in January 2019. Both applications seek to register the same piece of land (as a town or village green). To avoid unnecessary duplication both applications may be processed in parallel, although separate decisions will be made on each.

Notice is hereby given that an application has been made by **Ian McIntyre** ("The Applicant") to Cumbria County Council as commons registration authority, concerning land known as 'The Celtic', located at the junction of Empress Drive and Mikasa Street, South Walney, Barrow-in-Furness, as shown outlined in red on the attached plan ("the Application Land").

The summary of the effect of the application is as follows: The Applicant seeks the inclusion in the register of town and village greens of the Application Land, which is claimed to have qualified for registration as a town or village green on 4th April 2022, by virtue of its claimed use for lawful sports and pastimes by local inhabitants, as of right, for not less than 20 years.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by registering the Application Land as a new town or village green.

Representations:

- must quote the Application No. **CA9/8**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and


Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at **5pm on 24th June 2022**.

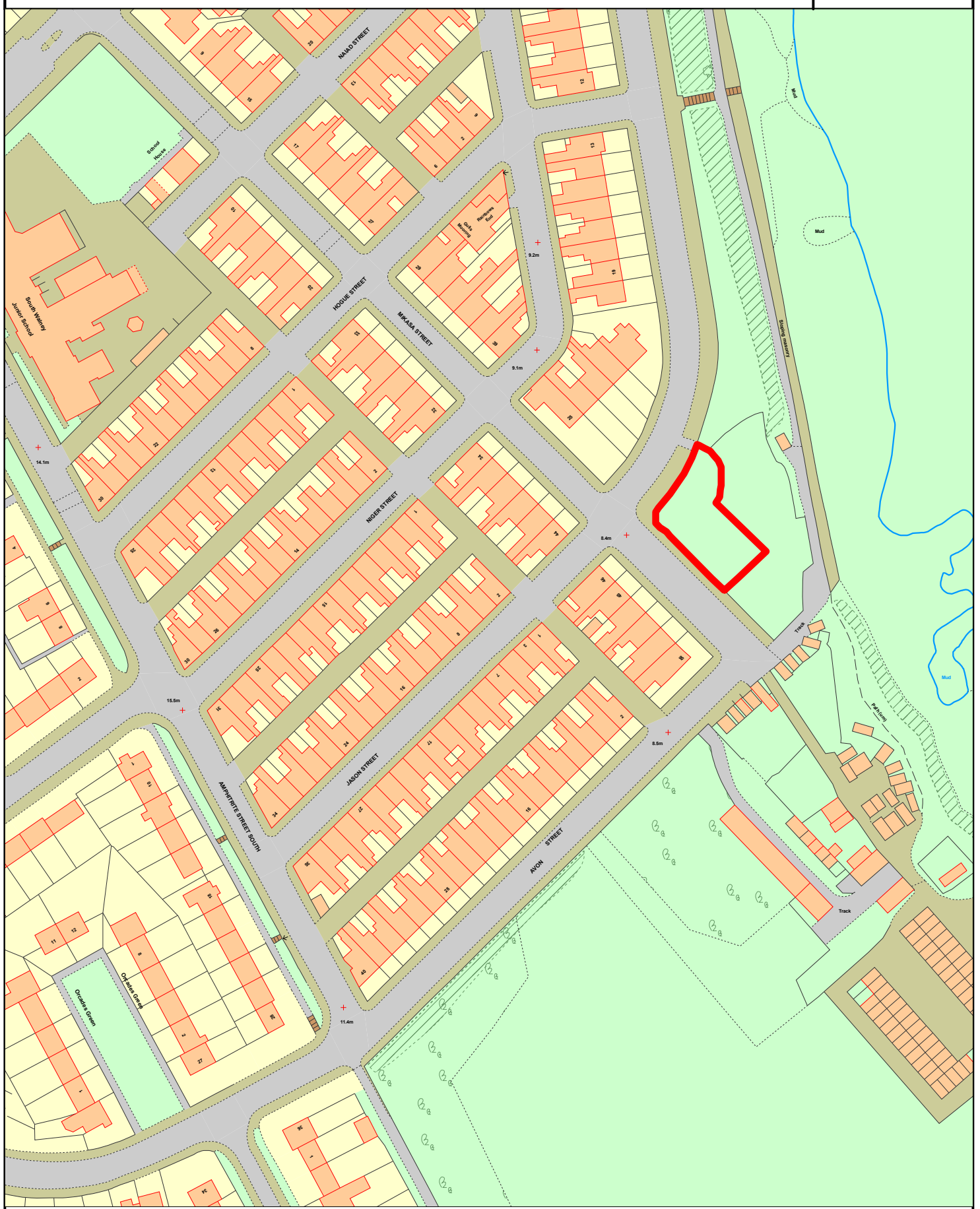
