## Adoption Statement – Statement of Community Involvement

Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended)

In accordance with the above regulations, notice is hereby given that the Statement of Community Involvement was adopted by Cumberland Council on 18<sup>th</sup> February 2025.

The Statement of Community Involvement sets out how the Council will involve the local community and interested parties in the planning process to ensure that those that want to can influence and shape the areas they live and work in.

A draft version of the Statement of Community Involvement was released for a sixweek consultation period on the 13<sup>th</sup> September 2024. Following the consultation, the Council has produced a Consultation Statement which summarises the comments received and the Council's response to them; it also identifies where necessary changes have been made to the document to take representations into account.
